Subject: Re: SD 16 Sen. Miller New Recall Registration 3/5/11 and Insufficiencies Notice

Mr. Baltus:

On March 5, 2011, our office received an electronic CFIS filing for a recall registration statement against SD 16, Senator Miller. This recall registration statement lists John Rolfsmeyer of Madison as the Petitioner. Please note that we have not received a paper copy of the signed GAB 1 and we do not have a paper copy of the Statement of Intent. **Pursuant to Sec. GAB 6.02(2), Wis. Adm. Code, you have 15 days from the date of this email to correct these insufficiencies. Failure to do so will result in the rejection or lapse of the registrations and they will not be effective.**

For clarification purposes, please note that our office previously notified you that we rejected your recall registration statement for SD 12 and 16, dated February 18, 2011. Second, we also previously notified you that the recall registration for SD 16 with petitioner Mary Bryant, 201 Orchard Street, Oregon, WI 53575, dated February 23, 2011 was rejected because the petitioner does not reside in SD 16, but in fact resides in SD 27.

However, please note that we did confirm that we had the electronic filing of the recall registration statement for Sen. Miller (SD 16) dated February 23, 2011; however, it remains insufficient as we do not have the paper copies or statements of intent to recall. **On March 3, 2011, I notified you that pursuant to Sec. GAB 6.02(2), Wis. Adm. Code, you had 15 days to correct these insufficiencies related to the February 23, 2011 electronic CFIS recall registration statement filing for SD 16. Failure to provide those documents by 5 p.m. on Friday, March 18, 2011, will result in the rejection or lapse of the registration and it will not be effective, meaning any signatures collected will also not be valid.**

Please confirm whether you intend to complete the February 23, 2011 filing for SD 16, or if you have withdrawn that registration and are relying on the March 5, 2011 filing.
