Please note that this registration was complete on March 15, 2011 for purposes of beginning the recall petition circulation period; however, a requested paper copy of the GAB 1 and statement of intent has not been received. Please find enclosed an email notice to Mr. Baltes of the American Recall Coalition regarding remaining insufficiencies that can be corrected within 15 days of the date of the email notice.

As soon as we receive the requested statement of intent, we will provide you with a copy of correspondence to the American Recall Coalition recall committee regarding their recall petition effort and which notifies them of the deadline for filing a petition, numbers of signatures needed, and campaign finance reporting requirements.
