I have personal knowledge of these facts, as I properly wrote the date and was the circulator.

to the partisan election, the candidacy and ballot access of David A. VanderLeest in the said August 14, 2012 Primary Election and Fall General Partisan Election, and such other lawful purposes as the Board and Court of competent jurisdiction may deem necessary and proper.
