
RE: CHALLENGE TO NOMINATION SIGNATURES OF ERIC WIMBERGER 90th

AFFIDAVIT

Before me, the undersigned authority, personally appeared ERIC WIMBERGER, hereinafter the Affiant, who being duly sworn by me, on oath, deposes and says:

On 5 June 2014 I received notice from a GAB representative that Shae Sortwell challenged nomination signatures for my candidacy in the race for 90th Assembly. In opposition to his complaints I offer the following in rebuttal. As Sortwell's complaints are not individually numbered, I try to avoid confusion by addressing them each in order from the beginning of Sortwell's complaints as written.

COMPLAINT 1

I, Shae Sortwell, allege that the following nominations are invalid due to the address of the candidate being invalid. The address 1146 Pine Street, Green Bay, WI 54201 is not a valid postal address as there are more than one unit and it was not specified in the papers. Pages 1-25, all nominations all invalidated by this error.

I further allege that this invalid address is used also as the circulator's address for all nomination pages circulated by Eric Wimberger personally. This would invalidate all signatues on pages 1-15,20, 23 and 25.

RESPONSE TO COMPLAINT 1

I live at 1146 Pine Street, Green Bay, Wisconsin 54301 as described on the nomination papers. I do not know who lives at 1146 Pine Street, Green Bay, Wisconsin 54201. My mail gets delivered to my address. I have enclosed recent statements, personal information redacted, that arrive every month to my address, delivered by the U.S. Postal Service without fail. (See exhibit 1.a, 1.b, 1.c)

COMPLAINT 2

I, Shae Sortwell, allege that on the following nominations are invalid due to the Title of the Office being incorrect. Both candidates Eric Genrich and Shae Sortwell followed the clear instructions of the GAB and used the proper title of "Representative to the Assembly". I understand that the GAB is understanding of other clear titles being acceptable but this does not fit that guideline. It does not say "Assemblyman" or any other such synonym to the requisite title. Instead, it does not use a title of office at all. Pages 1-25, all nominations all invalidated by this error.

RESPONSE TO COMPLAINT 2

While Sortwell may be right on best practices, the phrase "Assembly 90th" is acceptable to the GAB. Prior to submitting nomination papers, I called the GAB and spoke with an election specialist and confirmed that there was not a problem. The phrase used is specific enough as to not be confusing in any way to the position described.

COMPLAINT 3

I, Shae Sortwell, allege that on the following nominations are invalid due to the pages having gaps in the wording at the top due to what appears to be a hole punching. Any signer would not have been able to read this section and been unaware of what it said. Therefore, the signers could not have been fully informed as to what they were signing and by section 8.15(4)(a) they need to have "full knowledge of its content". Pages 1-25, all nominations all invalidated by this error.

RESPONSE TO COMPLAINT 3

In an effort to maintain order in the nomination papers, I three hole punched the documents and placed them into a three ring binder. Any disruption at the top of the nomination page is so insignificant as to be unnoticeable except to someone searching for a reason to make a complaint of this type. Sortwell does not present any evidence that

someone was actually confused about the nomination papers and lacked “full knowledge and consent.” Rather, Sortwell demands the GAB finds a fact that does not exist.

COMPLAINT 4

I, Shae Sortwell, allege that the circulator Rachel M. Rose did not provide a proper address of her residency, thus falsifying the nomination forms that she circulated as it says quite specifically that "I reside at" and "Circulator's residence" on the circulation forms. Upon research, it was found that the address provided is the Sophie Beaumont office building of the Brown County Government, not a residential address. Please see the attached evidence. The pages are thus falsified and invalidated are pages 16, 17, 18, and 25, all of which were circulated by her and provided a false residence.

RESPONSE TO COMPLAINT 4

Rachel Rose is a friend who is homeless. She resides in the 90th Assembly district for voting purposes. Like all homeless persons in Green Bay who need to list an address for any purpose such as mail, government services, state identification, etc., Rachel Rose listed the Beaumont Building at 111 North Jefferson Street as her address. (See Exhibit 2)

COMPLAINT 5

I, Shae Sortwell, allege that on the following nominations are invalid due their having been signed by the same person yet at an earlier date on another candidate's nominations for the same office at the same election.

Line 5: dated 5/30/2014

This is invalidated by the signature nominating Shae Sortwell on his circulation sheet, page 7, Line 2, dated 5/17/2014.

Line 7: dated 5-30-14

This is invalidated by the signature nominating Shae Sortwell on his circulation sheet, page 7, Line 9, dated 5-17-14.

Page 21

Line 9: dated 5-27-14

This is invalidated by the signature nominating Shae Sortwell on his circulation sheet page 25, Line 1, dated 5/18/14.

Page 24

Line 3: dated 5/30/14

This is invalidated by the signature nominating Shae Sortwell on his circulation sheet, page 7, Line 1, dated 5/17/14.

Line 4: dated 5/30/14

This is invalidated by the signature nominating Shae Sortwell on his circulation sheet, page 7, Line 3, dated 5/17/14.

Line 6: dated 5-30-14

This is invalidated by the signature nominating Shae Sortwell on his circulation sheet, page 4, Line 9, dated 5-17-14

RESPONSE TO COMPLAINT 5

I lack any knowledge regarding his nomination papers or whether the signors he described are the same as mine and signed his nomination papers first. As such, I assert my signatures are valid and put Sortwell to his proof.

COMPLAINT 6

I, Shae Sortwell, allege that on the following nomination is invalid due to the address being provided is not a proper voting address for Assembly District 90 as it is the Sophie Beaumont Building and not a residence for voting purposes.

RESPONSE TO COMPLAINT 6

Rachel Rose is a friend who is homeless. She resides in the 90th Assembly district for voting purposes. Like all homeless persons in Green Bay who need to list an address for any purpose such as mail, government services, state identification, etc., Rachel Rose listed the Beaumont Building at 111 North Jefferson Street as her address. (See Exhibit 2)

COMPLAINT 7

I, Shae Sortwell, allege that all the nominations on page 7 are invalid due to an invalid date of signing by the circulator on the bottom of said page.

RESPONSE TO COMPLAINT 7

Except for the year that may appear unclear, I do not know what Sortwell alleges. I placed the year at “2014,” though I understand how Sortwell may be mistaken and overlooked the small “0” in “2014.” I do not know what was happening in the 90th Assembly District on 30 May 214, but I’m sure I wasn’t circulating nomination papers then. I contend that the reasonable viewing of the date on the bottom of page 7 is “30 May 2014,” the date that I signed it.

COMPLAINT 8

I, Shae Sortwell, allege that on the following nominations are invalid due to the signers having committed at least 1 felony and are disqualified from voting under 6.03. Wis. Stats.

RESPONSE TO COMPLAINT 8

Sortwell is simply mistaken about the law. Wisconsin Statute §6.03 prohibits felons serving a sentence from voting or doing things as an “elector” like signing nomination papers. Clearly described in §6.03(1)(b), however, is a cross reference to Wisconsin Statute §304.078(3). §304.078(3) specifically describes that felons who have completed their term of “imprisonment” or “probation” have their voting rights restored and are “electors.”

Prior to 1998 “truth in sentencing” legislation in Wisconsin, a person convicted of a felony served a term of confinement and then parole. A felon’s voting rights were restored after completing parole. After 1998, a person convicted of a felony and sentenced to prison serves a term of “initial confinement” and then “extended supervision.” A felon’s voting rights are restored after completing extended supervision. If there is a felony conviction, but only a jail sentence is imposed with probation, voting rights are restored upon completing probation.

Further, Sortwell provides as evidence what appear to be excerpts from a notoriously inaccurate online database “CCAP.” He does not provide any authenticated copy of a “judgment of conviction,” the document accepted by Wisconsin Rules of Evidence as proof of conviction. He does not provide any document from the Department of Corrections either. CCAP lists many people with the same name as others without convictions. CCAP also often does not take into account early release from supervision or sentence adjustments.

Addresses listed on CCAP are not the same as the addresses listed by the electors on the nomination papers. In fact, to the best of my determination, none of the addresses of the supposed ineligible felons listed on CCAP match the addresses of the signers.

Below is additional rebuttal specific to each individual in Sortwell's complaint, in the event those individuals on CCAP were the same signing electors:

Page 3

Line 8: Ezell Smith

If this signer is the same as on CCAP, the signature is invalid.

Line 9: Nona McCullar

This elector was convicted on 16 March 2009 and spent 45 days in jail. Probation ended 2 years and 6 months later, well before signing the nomination paper. (See Exhibit 3)

Page 6

Line 2: Tyrone Kelly

This signor was convicted on 15 February 2008 and sentenced to 90 days jail with 2 years probation. Probation ended in 2010, well before signing the nomination papers. (See Exhibit 4)

Line 7: Jermaine Baker

This signor was convicted on 12 October 2010 and sentenced to 18 months confinement, followed by 18 months extended supervision. Extended supervision concluded in October 2013, before signing the nomination paper. (See Exhibit 5)

Page 19

Line 3; Michael Lavey

This signor was supposedly convicted in 1993. There is no record of what the conviction was for, other than a class "c" felony. With over 20 years since conviction for what is described only as a "c" felony, this signor has certainly completed any sentence. (See Exhibit 6)

Page 9

Line 4: Sean Hoover, (aka Derrick Smith)

Not only does Sortwell rely on an inaccurate database for his complaint, but he proposes that this signer is actually someone else with a felony record. There is no reliable evidence to support the assertion that Sean Hoover is an alias for Derrick Smith currently on extended supervision. (See Exhibit 7)

Line 8: Shamika Murrell

This signor was sentenced to 4 months jail and 4 years probation on 25 November 2003. She completed any supervision in 2008, long before she signed a nomination paper. (See Exhibit 8)

Line 9: Ken Duellman

If this signer was convicted of a felony on or about 1989, he is surely completed with any supervision. Further, CCAP does not even describe the “disposition,” in this signer’s case. As such, he is presumed innocent and without conviction whatsoever. The CCAP record indicates the “case status” as “closed.” There is no indication of a plea or finding of guilt. (See Exhibit 9

Page 4

Line 7: Robert Rosh

Sortwell provided the CCAP record for Robert Rush, not Robert Rosh. Robert Rush has a felony record on CCAP, where the conviction was on 28 July 2006. He received a sentence of 90 days jail and no probation. His sentence was complete and voting rights restored in 2006, well before signing a nomination paper. That is true, of course, is Robert Rosh is Robert Rush. (See Exhibit 10)

Line 9: Jeff Condiff

A Jeff Condiff of Milwaukee appears to have been convicted in on 15 April 2005. He received a 6 month jail sentence with no probation. If he is the signer, his voting rights have been restored. (See Exhibit 11)

Page 7

Line 2: Julius Lindsey

This signer was convicted on 20 February 2007. He received 2 years initial confinement, and 2 years extended supervision. His voting rights were restored sometime in 2011, well before signing any nomination paper. (See Exhibit 12)

Page 5

Line 1: Heather Williams

This complaint is a perfect example of how reliance on CCAP alone is improper. The exhibit shows just how many people named Heather Williams there are with criminal records. There are likely many times more people with the same name without a criminal record. Sortwell cherry picks case 2000CF216 since the conviction was in Brown County. However, a conviction in Brown County has nothing to do with compliance with Wis Stat §6.03. The Heather Williams convicted on 23 May 2000 lived on Badger Street, Green Bay, while the signer Heather Williams lives on Maple Avenue, Green Bay.

Regardless, the felon Heather Williams was revoked from probation on 14 March 2003. After credit for time served, she was sentenced to serve 4

months jail from that date. Her voting rights were restored in 2003, well before signing any nomination paper in 2014. (See Exhibit 13)

Line 10: Justin Fields Sr

This signer was convicted on 24 April 2006. He received a sentence of 1 year in prison followed by 6 years of probation. His voting rights were restored in 2013, before signing any nomination paper in 2014. (See Exhibit 14)

Page 20

Line 4: Cory Walsh

Sortwell complains that the signer Cory Walsh is an ineligible elector, yet the nomination paper describes Cory Welsh. The CCAP record for Cory Welsh that Sortwell provided as an exhibit indicates a conviction on 30 August 2006. He was sentenced to 2 years in prison followed by 5 years of extended supervision. He was revoked from extended supervision on 17 March 2009 and spent an additional 1 year and 10 months in prison. His sentence appears to be complete and his voting rights restored. (See Exhibit 15)

Page 2

Line 2: Michael Berck

This signer was convicted on 22 April 2009 and sentenced to 2 years prison and 3 years extended supervision. He was given pre-trial confinement credit of 145 days. His voting rights were therefore restored early in 2014, before signing nomination papers. (See Exhibit 16)

Page 25

Line 4: Thomas Gepperth

If this signer is the same as the felon, then the signature is invalid.

Page 17

Line 8: James Stenberg

Sortwell complains of a felony conviction on 2003CF751. That sentence was served and that conviction does not make the signer ineligible, if the signer and the felon are the same person. The address of the signer is different than the CCAP record. (See Exhibit 17)

COMPLAINT 9

I, Shae Sortwell, allege that on page 17, line 7, a non-existent address was provided of "1444 uni ave". As there is no "uni ave" in the voting district, there is no way to verify the nominator's eligibility to sign.

I further allege that on Page 9, line 3 a non-existent address was provided of "106 Lawe St". As there is no "106 Lawe St" in the voting district, the nomination is invalid.

I further allege that on Page 11, line 10 a non-existent address was provided of "1381 Eliza Sf. As there is no "1381 Eliza St" in the voting district, the nomination is invalid.

RESPONSE TO COMPLAINT 9

I have every reason to believe that the “uni” in the writing of “1444 uni ave” is a typical abbreviation for “University Avenue,” an address clearly within the boundaries of the 90th Assembly district.

Elector Kevin Buttraw signed that he lived at 106 Lawe Street. I have no reason to believe he misrepresented his address. The entirety of Lawe Street is inside the 90th Assembly district.

Elector Jim Buchholz signed that he lived at 1381 Eliza Street. I have no reason to believe he misrepresented his address. That address is at the corner of Eliza Street and Baird Ave. The entirety of Eliza Street is in the 90th Assembly District.

I, Shae Sortwell, allege that on the following nominations are invalid due to the addresses being provided aie outside of the voting are for Assembly District 90


RESPONSE TO COMPLAINT 11





When I obtained the signatures I tried to follow the rules on the paper and the instructions that Eric Wimberger gave me as best I could.

Since I have no permanent address, I do what all the homeless persons in Brown County do on any paperwork, list my address at the Beaumont Building, 111 North Jefferson Street, Green Bay. My mail is delivered to that address, and I really don't know what address I would otherwise have written on the nomination papers. I am an eligible voter who would vote in the 90th Assembly District due to my address at 111 North Jefferson Street.



Since I have no permanent address, I do what all the homeless persons in Brown County do on any paperwork, list my address at the Beaumont Building, 111 North Jefferson Street, Green Bay. My mail is delivered to that address, and I really don't know what address I would otherwise have written on the nomination papers. I am an eligible voter who would vote in the 90th Assembly District due to my address at 111 North Jefferson Street.
