This communication is in direct response to the challenges made by Representative Kessler regarding circulator / signatures turned in to the GAB on Friday, June 1, 2012. Please except this email as my response in writing from Mario Hall.

Challenges 6 through 9: The nomination papers were correctly circulated with the candidate's address printed at the top of the page. The circulator mistakenly wrote down Milwaukee as the municipality of residence or failed to list again the municipality of residence after circulating the papers. The citizens who signed the papers were clearly told the candidate and circulator's municipality of residence in printed type at the top of each page.

Challenges 10 and 11: It is true the citizens who signed the nomination papers on these two pages didn't list the year of their signature; they only listed the month and date. There are other multiple indications of the year on the nomination papers. It is ridiculous to suggest that they were signed in any year other than 2012. Indeed, the GAB form appears to suggest it was created in 2011-09 which would have made it impossible for the form to have been circulated in any April or May other than 2012.

Challenges 13, 16 and 20: It is true the citizens who signed the nomination papers on these pages didn't list the year of their signature; they only listed the month and date. There are other multiple indications of the year on the nomination papers. It is ridiculous to suggest that they were signed in any year other than 2012.

Challenge 18: I believe that line 10 is in the 12<sup>th</sup> State Assembly District


