This complaint is under Chapter 8 of the Wisconsin Statutes and GAB 2 of the State of Wisconsin Administrative Code. I, Jennifer Toftness allege that:

1. I am a resident of the State of Wisconsin, a qualified elector, and the Executive Director of the Republican Assembly Campaign Committee with a mailing address of 148 East Johnson Street, Madison, Wisconsin 53703.
2. Eric Prudent for State Assembly is the personal campaign committee for Eric Prudent, who listed his address, as filed with the Government Accountability Board, as 206 N. University Drive, Waukesha, WI, 53188, has filed nomination papers with the Government Accountability Board for certification as a Democratic candidate for State Assembly for Wisconsin's 63rd District (the "District") on the November 6, 2012 ballot.

DUPLICATE SIGNATURES

3. Electors may not sign the nomination paper of any other candidate for the same office. The following Nomination Paper entry appears on both Paul Farrow, candidate for 98th Assembly District, nomination papers, page 25, line 3 (attached as Exh. T), and also on Eric Prudent, candidate for 98th Assembly District, nomination papers, page 9, line 7 (attached as Exh. U).

**SIGNATURES MISSING COMPLETE ADDRESS, MUNICIPALITY,
OR CORRECT MUNICIPALITY OF RESIDENCE**

4. To be valid, the petitions must contain "a complete address, including municipality of residence for voting purposes, and the street and number, if any, of the residence...shall be listed for each signature on a nomination paper." GAB 2.05(12).

5. Signatures may not be counted where the “address of the signer is missing or incomplete, unless the residency can be determined by the information provided on the nomination paper.” GAB 2.07(16)(c).
6. If it is established that “the address of the signer, is not valid, the signature may not be counted.” GAB 2.07(3)(c).
7. In addition, Wisconsin law requires that “each signer of a nomination paper shall list his or her municipality of residence for voting purposes, the street and number, if any, on which the signer resides.” Wis. Stat. § 8.15(2).

SIGNER RESIDES OUTSIDE OF DISTRICT

12. To be valid, "all signers on each separate nomination paper...shall reside in the jurisdiction or district which the candidate named on the paper will represent, if elected." Wis. Stat. § 8.15(3)
13. Page 17, line 3 of Respondent's nomination papers are signed by an individual who listed his/her municipality of residence as 1273 River Place Blvd., Waukesha, WI. A copy of page 17 is attached hereto as Exhibit A. *See* Exhibit B from the State of Wisconsin State Legislature's "Who is My Legislator" website as administered and maintained by the Legislative Technology Service Bureau, clearly demonstrates that the location of the residence falls within Assembly District 97, in contravention of Wis. Stat. § 8.15(3).
14. Page 20, line 6 of Respondent's nomination papers are signed by an individual who listed his/her municipality of residence as 134 W. North St., Apt. 311, Waukesha, WI. A copy of page 20 is attached hereto as Exhibit C. *See* Exhibit D from the State of Wisconsin State Legislature's "Who is My Legislator" website as administered and maintained by the Legislative Technology Service Bureau, clearly demonstrates that the location of the residence falls within Assembly District 97, in contravention of Wis. Stat. § 8.15(3).

WHEREFORE, Complainant prays that the Government Accountability Board review the sufficiency of Respondent's nomination papers and declare them to be invalid in whole or in part; and render such other relief that the Government Accountability Board may deem just and equitable.


