Sarah Scott, first being duly sworn, and through counsel, states as follows:

1. I am an adult resident of the 30th State Senate District, residing at 1021 S. Irwin Avenue, Green Bay, Wisconsin. I am a qualified elector, i.e., either registered to vote or eligible to register and vote.

2. I am aware that on or about June 21, 2011, John Nygren filed with the Government Accountability Board nomination papers for candidacy in the recall election for the 30th Senate District (“Nomination Papers”).

3. As qualified elector of the 30th Senate District, I am filing this written challenge to the sufficiency of the Nomination Papers pursuant to §§ 5.05 and 5.06, Wis. Stats and GAB 2.07(1), Wis. Admin. Code.

4. Nomination papers for the office of state senate must contain at least 400 signatures pursuant to §§ 8.15(6)(c) and 8.50(3)(b), Wis. Stats.

5. The Nomination Papers purport to include approximately 424 signatures.

6. Upon information and belief, the Nomination Papers include the following irregularities, which are supported by the Affidavit of Michael L. Pfohl, attached hereto as Exhibit 1, and the Affidavit of Jason Kingsbury, attached hereto as Exhibit 3:

a. At least twenty-three signatories to the Nomination Papers reside outside of the 30th Senate District. Pursuant to §§ 8.15(3) and 8.50(3)(b), Wis. Stats., these signatures may not be counted.

b. The residency of at least twenty-five signatories to the Nomination Papers cannot be determined by the address given. Pursuant to §§ 8.15(2) and 8.50(3)(b), Wis. Stats. and GAB 2.05(12), (15)(c) Wis. Admin. Code, these signatures may not be counted.

c. At least two signatories, Kathy Adams (page 22, line 2) and Susan Snyder (page 34, line 8), signed the Nomination Papers after signing nomination papers for David VanderLeest – a separate candidate for the same office. Pursuant to § 8.04, Wis. Stats. and GAB 2.05(11) Wis. Admin. Code, these signatures may not be counted.

d. At least one signatory signed the Nomination Papers more than once (page 28, line 3 and page 38, line 8). Pursuant to §§ 8.15(2) and 8.50(3)(b), Wis. Stats., only one of these duplicate signatures may be counted.

e. At least two signatures, Monte Mocco (page 43, line 3) and Maria Mocco (page 43, line 4), appear on their face to have been signed by the same person. Thus, at least one of signatories did not sign their own name in contravention of GAB 2.05(8)-(9), Wis. Admin. Code, and may not be counted.

f. One individual signed the petition Nomination Papers because she was led to believe that they were in support of Senator Dave Hansen instead of Nygren. *See* Exhibit 2, Affidavit of Marsha Lungstrom. Therefore, this signature may not be counted.

7. Given the above-referenced insufficiencies, the Nomination Papers do not contain a sufficient amount of valid signatures pursuant to §§ 8.15(6)(c) and 8.50(3)(b), Wis. Stats.


8. For the foregoing reasons, the Nomination Papers fail to meet the mandatory standards outlined in Wis. Stat. §§ 8.15 and 8.50 and are insufficient. Therefore, John Nygren is ineligible for ballot placement pursuant to § 8.30, Wis. Stats. and GAB 2.05(6) Wis. Admin. Code.

I, Sarah Scott, first being duly sworn upon oath, state that I personally read the above written challenge and that the above allegations are true and correct based on my personal knowledge and, as to those allegations stated on information and belief, I believe them to be true.



Michael L. Pfohl, first being duly sworn, and through counsel, states as follows:

1. I am an adult resident of the state of Wisconsin. I am owner of PF Data, LLC.

2. PF Data was retained by Jeremy Levinson of Friebert, Finerty & St. John, S.C, to provide data management and consulting services related to the review of signatures contained in the nomination papers filed by John Nygren for candidacy in the state senate recall election for Senate District 30 ("Nomination Papers").

3. As part of my duties with PF Data I served as the lead point person for this project, and I have reviewed the signatures contained in the Nomination Papers.

4. Based upon this review I have found the following deficiencies:

a. At least 23 signatories to the Nomination Papers reside outside of the 30th Senate District. See Exhibit A.

b. The residency of at least 25 signatories to the Nomination Papers cannot be determined by the address given. See Exhibit B.

c. At least two signatories, Kathy Adams (page 22, line 2) and Susan Snyder (page 34, line 8), signed the Nomination Papers after signing nomination papers for David VanderLeest – a separate candidate for the same office. See Exhibit C.

d. At least one signatory signed the Nomination Papers more than once (page 28, line 3 and page 38, line 8).

e. At least two signatures, Monte Mocco (page 43, line 3) and Maria Mocco (page 43, line 4), appear on their face to have been signed by the same person. Thus, at least one of signatories did not sign their own name in contravention of GAB 2.05(8)-(9), Wis. Admin. Code, and may not be counted.

5. Based on the above-detailed deficiencies, the Nomination Papers do not contain a sufficient number of signatures to place John Nygren on the ballot.
