## Voter Intent



- Wis. Stat. § 7.50(2)(em): When write-in votes may be counted for registered vs. non-registered candidates
- Wis. Stat. § 7.52(2)(d): When write-in votes may be counted vs. ballot candidate votes
- The Four Principles for Determining Eligibility of Write-In Votes.


## Registered Write-Ins



- A candidate who wishes to run as a write-in is required to file a Campaign Registration Statement (CF-1) by 12:00 p.m. the Friday before the election.
- If the candidate has already filed an CF-1 with the filing officer and decides to run as a write-in, WEC recommends the candidate submit a written statement to that effect to the filing officer.
- The municipal clerk should give the election inspectors a list of registered write-ins. A voter who asks if there are any registered write-ins should be allowed to look at the list. The list should not be posted or otherwise offered to voters.

## The Four Principles for Determining Eligibility of Write-in Votes

1. If the number of ballot candidates for a given office is equal to or greater than the number of seats to be filled-

Only votes for registered write-in candidates are eligible for
counting.
(A ballot candidate whose name is written in under a different office than the office where the candidate's name is printed cannot be counted in this situation.)
2. If there are fewer ballot candidates for a given office than the number of seats to be filled-

## All write-in votes are eligible for counting.

(A ballot candidate whose name is written in under a different office than the office where the candidate's name is printed is counted in this situation.)
3. If there are any ballot candidates for a given office and one or more has passed away-

## All write-in votes are eligible for counting.

(A ballot candidate whose name is written in under a different office than the office where the candidate's name is printed is counted in this situation.)
4. If there are enough write-in votes to fill the number of seats up for election (regardless of the eligibility of the write-in votes)-

Votes for ballot candidates may not be considered.

## Other items to bear in mind

A false notion among clerks and poll workers is that if a ballot candidate is deceased but the candidate's name remains on the ballot, votes for that candidate are ignored. They are counted. If the deceased candidate wins, it creates a vacancy for that office.

In addition, if a winning candidate declines the seat, the candidate with the next highest number of votes does not win. It creates a vacancy for that office.

The Alarmingly Insidious Fallacy that Optical Scan Equipment is Infallible.
This is the extent of the analytical skills and mathematical aptitude of optical scan equipment.

## Optical Scan can:

- look for completed arrows and ovals and count them.
- determine cross-over votes in a partisan primary
- determine if the number of marked ovals or arrows is more than the voter can vote for.
- If it sees more marked ovals or arrows than allowed, it counts nothing-which is not always correct.


## Optical scan cannot:

- think or reason
- kick out overvotes caused by write-in votes so election inspectors don't have to count them
- figure out write-ins for so election inspectors don't have to
- see and "read" handwriting
- know the difference between registered write-in candidates and those that are not registered


## Counting Votes: Voter 1

## Registered Write-in Candidates

Question 1: How many votes is the voter entitled to cast? (Refer to the ballot instructions.)

- One. The instructions are "Vote for not more than 1."
- The voter has cast a vote for 2 candidates, which is one too many.

Question 2: Are all write-in votes eligible for counting or only votes cast for registered write-in candidates? (Refer to Principle 1)

- There is 1 position to be filled and 1 ballot candidate.
- Only votes for registered write-in candidates are eligible to be counted.

Question 3: Is the write-in candidate registered?

- Izzy Serton is a registered write-in candidate. The vote for Izzy Serton is counted.

Question 4: Are there enough write-in votes to fill the seats up for election? (Refer to Principle 4)

- Yes. There is 1 position to be filled and 1 write-in vote. There are enough write-in votes to fill the 1 position. Ballot candidates may not be considered.

Final result

- There are 2 votes marked. The write-in vote for Izzy Serton is counted for this office, the vote for Ida Thotos is not counted.
- The voting equipment has recorded a vote for Ida (because Ida's oval is filled in) and has not recorded a vote for Izzy.
- Adjust the tape to subtract a vote from Ida and add a vote for Izzy.

## Counting Votes: Voter 2

## Registered Write-in Candidates

Fanny Hill
Izzy Serton


How many votes is the voter entitled to cast? (Refer to the ballot instructions.)

- One. The instructions are "Vote for not more than 1."
- The voter has cast a vote for 1 candidate, which is what the voter is entitled to.

Question 2: Are all write-in votes eligible for counting or only votes cast for registered write-in candidates? (Refer to Principle 2)

- There is 1 position to be filled and no ballot candidates.
- All write-in votes are eligible for counting.

Question 3: Is the write-in candidate registered?

- Robert Plant is not a registered write-in candidate, but all write-ins are eligible for counting. The vote for Robert Plant is counted.

Question 4: Are there enough write-in votes to fill the seats up for election? (Refer to Principle 4)

- Yes. There is 1 position to be filled and 1 write-in vote. There are enough write-in votes to fill the 1 position. Regardless, there are no ballot candidates to consider.

Final result

- There is 1 vote marked. The vote for Robert Plant is counted.


## Counting Votes: Voter 3

## Registered Write-in Candidates

Izzy Serton
Nell Carter


Question 1: How many votes is the voter entitled to cast? (Refer to the ballot instructions.)

- One. The instructions are "Vote for not more than 1."
- The voter has cast a vote for 2 candidates, which is one too many.

Question 2: Are all write-in votes eligible for counting or only votes cast for registered write-in candidates? (Refer to Principle 1)

- There is 1 position to be filled and 1 ballot candidate.
- Only votes for registered write-in candidates are eligible to be counted.

Question 3: Is the write-in candidate registered?

- Izzy Serton and Nell Carter are registered write-in candidates. The voter has written in two candidates and is only entitled to one vote. Voter intent cannot be determined between the two write-in votes. The votes for Izzy and Nell are not counted.

Question 4: Are there enough write-in votes to fill the seats up for election? (Refer to Principle 4.)

- Yes. There is 1 position to be filled and 2 write-in votes. There are enough write-in votes to fill the 1 position. Ballot candidates may not be considered.

Final result

- There are 2 votes marked. Votes for neither candidate may be counted.


## Counting Votes: Voter 4

## Registered Write-in Candidates

Question 1: How many votes is the voter entitled to cast? (Refer to the ballot instructions.)

- Two. The instructions are "Vote for not more than 2."
- The voter has cast votes for 3 candidates, which is one too many.

Question 2: Are all write-in votes eligible for counting or only votes cast for registered write-in candidates? (Refer to Principle 1)

- There are 2 positions to be filled and 2 ballot candidates.
- Only votes for registered write-in candidates are eligible to be counted.

Question 3: Is the write-in candidate registered?

- Martin Sheen is not a registered write-in. Only registered write-ins can be counted for this contest, so the vote for Martin Sheen is not counted.

Question 4: Are there enough write-in votes to fill the seats up for election? (Refer to Principle 4.)

- No. There are 2 positions to be filled and 1 write-in vote. There are not enough write-in votes to fill the 2 positions. Ballot candidates may be considered.


## Final result

- There are 3 votes marked. The votes for ballot candidates Wanda Round and Bill Melator are counted for this office.
- The voting equipment has recorded this office as overvoted (3 ovals filled in for a Vote for 2 contest)-no votes were recorded by the voting equipment.
- Adjust the tape to reflect two votes for the ballot candidates.

## Counting Votes: Voter 5

## Registered Write-in Candidates

Question 1: How many votes is the voter entitled to cast? (Refer to the ballot instructions.)

- Two. The instructions are "Vote for not more than 2."
- The voter has cast a vote for 3 candidates, which is one too many.

Question 2: Are all write-in votes eligible for counting or only votes cast for registered write-in candidates? (Refer to Principle 1)

- There are 2 positions to be filled and 2 ballot candidates.
- Only votes for registered write-in candidates are eligible to be counted.

Question 3: Is the write-in candidate registered?

- Fanny Hill is a registered write-in candidate. The vote for Fanny Hill is counted.
- The voter is entitled to two votes; one vote is cast for Fanny Hill.

Question 4: Are there enough write-in votes to fill the seats up for election? (Refer to Principle 4)

- No. There are 2 positions to be filled and only one write-in vote. There are not enough write-in votes to fill the 2 positions. Ballot candidates may be considered.
- There are two marked ballot candidates, and the voter is only entitled to one more vote. The votes for Wanda Round and Bill Melator would give the voter too many votes so neither vote is counted.

Final result

- There are 3 votes marked on the example ballot. Only the vote for Fanny Hill is counted.
- The voting equipment has recorded this office as overvoted-no votes were recorded by the voting equipment.
- Adjust the tape to reflect the write-in vote for Fanny Hill.

## Counting Votes: Voter 6

Questions 1: How many votes is the voter entitled to cast? (Refer to the ballot instructions.)

- Two. The instructions are "Vote for not more than 2."
- The voter has cast a vote for 2 candidates.

Question 2: Are all write-in votes eligible for counting or only votes cast for registered write-in candidates? Ballot candidate Bill Melator has passed away (Refer to Principle 3)

- All write-in votes are eligible to be counted.

Question 3: Is the write-in candidate registered?

- Martin Sheen is not a registered write-in candidate, but ballot candidate Bill Melator has passed away, so all write-in candidates are eligible to be counted. (Refer to Principle 3) The vote for Martin Sheen is counted.
- The voter is entitled to two votes, one vote is cast for Martin Sheen.

Question 4: Are there enough write-in votes to fill the seats up for election? (Refer to Principle 4.)

- No. There are 2 positions to be filled and only one write-in vote. There are not enough write-in votes to fill the 2 positions. Ballot candidates can be considered.
- There is one marked ballot candidate, and the voter is entitled to another vote. The vote for Bill Melator is counted.
- The votes for Bill Melator and Martin Sheen are counted.


## Counting Votes: Voter 7

## Registered Write-in Candidates

Question 1: How many votes is the voter entitled to cast? (Refer to the ballot instructions.)

- Two. The instructions are "Vote for not more than 2."
- The voter has cast a vote for 3 candidates, which is one too many.

Question 2: Are all write-in votes eligible for counting or only votes cast for registered write-in candidates? (Refer to Principle 2)

- There are 2 positions to be filled and 1 ballot candidate.
- All write-in votes are eligible to be counted.

Question 3: Is the write-in candidate registered?

- Martin Sheen is not a registered write-in candidate. Izzy Serton is a registered write-in candidate. However, all write-ins are counted. The votes for Martin Sheen and Izzy Serton are both counted.
- The voter is entitled to two votes.

Question 4: Are there enough write-in votes to fill the seats up for election? (Refer to Principle 4.)

- Yes. There are 2 positions to be filled and two write-in votes. There are enough write-in votes to fill the 2 positions. Ballot candidates cannot be considered.
- There is one marked ballot candidate, but the voter is not entitled to any more votes. The vote for Wanda Round is not counted.

Final result

- There are 3 votes marked. Only the votes for Martin Sheen and Izzy Serton are counted.
- The voting equipment has recorded a vote for Wanda that needs to be adjusted on the machine tape. The voting equipment did not record a vote for Izzy Serton, which also needs to be adjusted on the machine tape.

Question 1: How many votes is the voter entitled to cast? (Refer to the ballot instructions.)

- Three. The instructions are "Vote for not more than 3."
- The voter has cast a vote for 3 candidates.

Question 2: Are all write-in votes eligible for counting or only votes cast for registered write-in candidates? (Refer to Principle 1)

- There are 3 positions to be filled and 3 ballot candidates.
- Only votes for registered write-in candidates are eligible to be counted.

Question 3: Is the write-in candidate registered?

- Mary Smith is not a registered write-in candidate. The vote for Mary is not counted.

Question 4: Are there enough write-in votes to fill the seats up for election? (Refer to Principle 4.)

- No. There are 3 positions to be filled and one write-in vote. There are not enough write-in votes to fill the 3 positions. Ballot candidates may be considered.

Final result

- There are 3 votes marked. The votes for Wanda Round and Rob R. Barron are counted for this office.
- The voting equipment has recorded a vote for the write-in. Adjust the tape to subtract one write-in vote.
