Dana Wachs and his gubernatorial campaign, Wachs for Wisconsin, by their attorneys Halling & Cayo S.C. by attorneys Jeremy P. Levinson and Stacie H. Rosenzweig, submit this verified response to the complaint of the Republican Party of Wisconsin and its Executive Director (collectively, "RPW") in the above-captioned matter.

The RPW's complaint is devoid of any basis in fact or law. It is a collection of assertions that are often made "on information and belief" that are flatly false. This is made clear by the most cursory review of the referenced petition pages and signatures.

The RPW seeks to disenfranchise eligible voters by discounting their decision to sign candidate Wachs' nomination papers for crass political advantage. In fact, and as the law makes clear, the nomination process, including the review and challenge process, is not about candidate Wachs or the RPW or Governor Walker. It is about protecting the central role voters hold in the process of deciding who is to lead Wisconsin and ensuring each voter's voice is counted.

The law and the actual facts confirm that nomination papers containing far more valid signatures than required were properly filed in support of the Wachs candidacy. The Commission should decline the RPW's invitation to negate the will of these voters and it should dismiss the complaint. The applicable legal standards are well established. They reject the pained and hypertechnical nitpicking on which the complaint is based. (And any standards would reject a complaint premised on falsehoods). The law requires "substantial compliance" with its requirements for nomination papers, not literal perfection. Where any required item of information on a nomination paper is incomplete, the filing officer shall accept the information as complete if there has been substantial compliance with the law. El 2.05(5). Contrary to the premise of the RPW's complaint, "[t]he object of election laws is to secure the rights of duly qualified electors and not to defeat them." *Stahovic v. Rajchel*, 122 Wis. 2d 3, 70, 376, 363 N.W.2d 243, 246 (Ct. App. 1984).

Wisconsin Administrative Code EL §§ 2.05(4) and 2.07(3)(a) provide: "Any information which appears on a nomination paper is entitled to a presumption of validity," and "[t]he burden is on the challenger to establish any insufficiency." Complainants must satisfy their burden with "clear and convincing evidence."<sup>1</sup> Wis. Admin Code EL § 2.07(4).

At the outset, the complaint fails to make any movement toward these standards for two reasons. First, the key allegation of each claim is made on "information and belief," and second, each fails to identify any particular or specific putative defect, offering only conclusory assertions. This is not "evidence" of any sort. *Webb v. Ocularra Holding, Inc.*, 2000 WI App 25, ¶ 33, 232 Wis. 2d 495, 518, 606 N.W.2d 552, 563 (*citing West Side Bank v. Marine Nat'l Exchange Bank*, 37 Wis.2d 661, 665–66, 155 N.W.2d 587 (1968). Devoid of *any* evidence, the complaint cannot begin to approach the requirement of "clear and convincing" evidence. Rather, the premise of the RPW's complaint is that the Commission erred with regard to the facial validity with regard several hundred signatures the RPW would like a do-over. This is not what is contemplated by the challenge process.

Setting this aside, each claim fails because they each rest on false allegations and conclusions.

#### Argument

### I. Count 1 Fails Because it Rests on a Flat Mischaracterization of the Two Certifications it Attacks


Count 1 asserts "on information and belief" that the certifications on pages 33 and 119 fail to indicate the circulators' municipality.

The certification on page 33 plainly indicates the circulator's municipality:

CERTIFICATION OF CIRCULATOR CALLS PAINT SI.H. M. F. Page No.

The circulator included his municipality of residence, Eagle Point, and, in parentheses, what is apparently his mailing address, Chippewa Falls. Suffice it to say, providing too much accurate information is not a basis for any challenge. *See Manual for Nomination Challenges* ("Manual") at 4.

Likewise, the certification on page 119 clearly identifies Eau Claire as the circulator's municipality:



Abbreviations are specifically deemed acceptable for identification of a municipality. *Manual* at 7. As a wholly separate matter, the zip code precisely identifies the municipality as Eau Claire. The United States Postal Service website illustrates:

Count 1 is devoid of merit because it is premised on demonstrably false assertions.

# II. Count 2 Fails Because its Generalized Conclusion of Some Unspecified Shortcoming in 312 Signers' Addresses is False

Count 2 alleges on "information and belief" that 312 signers failed to "fully indicate [their] residential address[es]." *Complaint* at 2. Attached hereto as Exhibit 1 is a spreadsheet setting forth an address by address analysis demonstrating that the attacked addresses handily meet the requirements.

As an aside, Count 2 undermines itself not only by failing to identify a single particular purported defect but also by attacking signatures already discounted by the Commission' staff review. *See, e.g., Page* 83, lines 1-3.

Count 2 fails because it too is premised on false conclusions about entirely proper signer addresses.

## III. Count 3 Fails Because it Attacks Legible Signer Names and Because it Ignores the Applicable Standard

Count 3 alleges on "information and belief" that 19 signers should be disregarded because their names are illegible. First, this assertion is false as demonstrated by Exhibit 2 hereto.

Second, Count 3 ignores the established standards which seek to secure the electors' right to sign and be counted and permits striking the signature unless *no* part of a name can be discerned. *Manual* at 6. Likewise, the entire name does not need be absolutely clear and it is not required that an exact spelling be readily ascertainable.

Count 3 fails because it too rests on false, conclusory allegations.

# IV. Count 4 is Unintelligible and, In Any Case, Attacks Perfectly Appropriate Signatures

Count 4 alleges on "information and belief" that 15 signers "did not sign [their] name[s] as required." The complaint does not detail any particular shortcoming. Review of the 15 signatures strongly suggests that the attack is premised on the notion that a printed name or an initial followed by a last name are not "signatures." This directly contradicts the Commission's promulgated standards.

The signature may be marked as the signer customarily marks his or her signature, including by using an "X" or by using either traditional printed letters or a handwritten signature.

Manual at 6. Count 4 fails because it attacks entirely proper signatures.

#### V. Count 5 Fails Because it Misstates Demonstrable Facts and Ignores Established Standards

Count 5 attacks 5 signatures, alleging that they are dated after the date of the certification. This claim is a pained and hyper-technical attack that omits key facts that confirm the signatures' validity. The signatures on page 68, lines 1-4 were initially dated May 23, 2018 in error. Prior to submission of the papers, the circulator corrected this mistake by crossing out "23" and writing in the correct day, "22," initialing the corrections before certifying the page. By definition these corrections were made based on the circulator's personal knowledge and subject to the certification.

As a separate matter, the correct dates for these four signatures, like the only assailed signature on page 98 (line 7) are readily apparent by the fact that the original signature is a single day off from those that follow, all with the same correct date. The signatures before and after line 7 on page 98 are all dated correctly, further confirming that line 7 was signed on May 5, 2018, the date the page was certified.

Count 5 fails because it is baseless. It mainly serves to confirm the RPW's focus on using hyper-technicalities and falsehoods to disenfranchise voters. The issue is whether electors actually signed on a correct date, something readily apparent here. "Catching" an elector who makes a minor clerical error but who otherwise provided all required information on a correct date flies in the face of long established law and policy:

The object of election laws is to secure the rights of duly qualified electors and not to defeat them.

Stahovic, supra.

#### Conclusion

Dana Wachs and Wachs for Wisconsin respectfully request dismissal of the complaint because it lacks any basis in law or fact, because it offers no evidence of any kind, and because it seeks to disenfranchise eligible voters who are entitled to have their signatures on a nomination paper counted and credited.
