COMPLAINT

Republican Party of Wisconsin, by and through its representative, Mark Morgan (“Complainant”), brings this complaint against Richard Pulcher (“Respondent”) and alleges as follows:

1. Complainant Mark Morgan is a qualified elector of the State of Wisconsin and is the Executive Director of the Republican Party of Wisconsin with a mailing address of 148 East Johnson Street, Madison, WI 53703.
2. Richard Pulcher is a declared candidate for State Senate District 29 with a mailing address of W13276 South Street, Lublin, Wisconsin, 54447.
3. On June 01, 2018, Respondent filed nomination papers containing 435 signatures with the Wisconsin Elections Commission to be placed on the ballot for the November 06, 2018 general election in the 29<sup>th</sup> State Senate District.
4. Wis. Stat. 8.15(6)(c) provides that the number of required signatures on nomination papers for the office of state senator shall be not less than 400 or more than 800 electors.
5. Respondent’s nomination papers contained a total of 56 signatures with insufficiencies pursuant to Wisconsin Administrative Code §§EL 2.05 – 2.07, bringing the total number of valid signatures submitted down to 379. A list of the insufficient signatures and evidence of their insufficiency is attached hereto and incorporated herein as Exhibit “A”.
6. Complainant respectfully submits that these facts warrant the Commission’s attention, and the Commission should take prompt action to eliminate from the nomination papers filed by Respondent all signatures that are insufficient pursuant to Wisconsin

Administrative Code §EL 2.05 – 2.07 and should find that Respondent does not meet the number of signatures required by Wis. Stat. 8.15(6)(c) to be placed on the ballot for the November 06, 2018 general election in the 29<sup>th</sup> State Senate district.

The above-referenced activity is sufficient to establish probable cause that Pulcher's nomination papers contains more than 56 signatures which are noncompliant with Wisconsin Administrative Code §§EL 2.05 – 2.07.

WHEREFORE, Complainant prays that the Elections Commission review and invalidate all above referenced nomination signatures for Richard Pulcher and reject his placement on the ballot.
