VERIFIED COMPLAINT

I, Douglas Hyant, upon information, personal knowledge, and belief, hereby allege and swear as follows:

1. This Complaint is brought against Ahna Key pursuant to Wis. Admn. Code EL § 2.07, Wis. Stat. § 8.15(2), Wis. Stat. § 8.15(3), and Wis. Stat. § 8.15(4)(a).
2. I am a qualified elector in and resident of the State of Wisconsin. I am the Executive Director of the Assembly Democratic Campaign Committee, with offices located at 15 North Pinckney Street, Suite 200 in the City of Madison, Wisconsin, Zip Code 53703.
3. The Respondent, Ahna Key, Wisconsin Elections Commission File Number 0105980, Receipt Number 295, maintains a residential address at 205 North Michigan Street, in the City of Prairie Du Chien, Wisconsin, Zip Code 53821.
4. On or about June 1, 2018, Respondent filed nomination papers with the Wisconsin Elections Commission to be placed on the November 6, 2018 ballot for State Representative in the 96th Assembly District. The Respondent's nomination papers contained

approximately 186 signatures as determined by initial review of the Wisconsin Elections Commission staff.

5. Upon a more detailed examination, Respondent's nomination papers contain numerous deficiencies, including but not limited to: signers who are not qualified electors due to felony convictions, electors who signed the petitioner's papers multiple times, and/or signers who did not provide their address and municipality information in the certification.

6. Respondent's nomination papers contained a total of five (5) signatures with insufficiencies pursuant to Wis. Admn. Code EL §§ 2.05 and 2.07, bringing the total number of valid signatures substantially below the 200 signature threshold required to be placed on the ballot for State Assembly.

I. ELECTOR(S) SIGNED THE PETITIONER'S NOMINATION PAPERS MULTIPLE TIMES

7. For nomination signatures to be valid pursuant to Wis. Stat. § 8.15(2), the signing elector must not have previously signed the nomination papers for the same candidate running for the same state office. Wis. Stat. § 8.15(2) (2015-16).

8. Pages 7 and 19 of Respondent's nomination papers include signature(s) from electors who previously signed nomination papers for the same candidate running for the same seat (i.e., duplicate signatures). This is a clear violation of Wis. Stat. § 8.15(2). Signature matches at issue are as follows: Page 7-9 and Page 19-4 (1 signature eliminated from Respondent's nomination papers).

9. Copies of the Respondent's nomination papers exhibiting this defect and the matching duplicate signatures from the Respondent's nomination papers are attached hereto and incorporated herein as "Exhibit A". In particular, one signatory, Jean Powers, signed the Respondent's nomination papers two (2) times, using one address, which was duplicated. A

comparison of the signatures clearly shows that both are the same individual. (See Signatures 7-9, 19-4).

II. SIGNERS WERE NOT QUALIFIED ELECTORS DUE TO FELONY CONVICTIONS

10. For nomination signatures to be valid, the signer must be a qualified elector in the district. Individuals who have been convicted of a felony and are currently serving any portion of their sentence, including extended supervision, probation, or parole, are not eligible to vote, and therefore are not electors qualified to sign nomination papers. *See* Wis. Stat. § 6.03(1)(b) (2015-16).

11. Pages 7 and 14 of Respondent's nomination papers includes two (2) signatures from electors disqualified due to a felony conviction, as confirmed via a CCAP search, *available at* wcca.wicourts.gov. Respondent's nomination signatures exhibiting this defect are located at Page 7 - 2 and 14-8 (2 additional signatures eliminated from Respondent's nomination papers).

12. Copies of the Respondent's nomination papers exhibiting this defect are attached hereto and incorporated herein as "Exhibit B". Screenshots of the CCAP records for each disqualified signatory are attached hereto and incorporated herein as "Exhibit C".

III. ELECTOR DID NOT PROVIDE REQUIRED ADDRESS AND MUNICIPALITY OF RESIDENCE

13. For nomination signatures to be valid pursuant to Wis. Stat. § 8.15(2), an elector signing the nomination papers for a state office, including that of Representative in the Wisconsin State Assembly, must provide their address and municipality of residence for voting purposes. Wis. Stat. § 8.15(2) (2015-16).

14. Page 14 of Respondent's nomination papers fail to correctly identify the address and/or municipality of residence of the Elector. This is a clear violation of Wis. Stat. § 8.15(2).

15. Copies of the Respondent's nomination papers exhibiting this defect are attached hereto and incorporated herein as "Exhibit D". Signatures exhibiting this defect are as follows: Page 14-8, 9 and 10 (3 additional signatures eliminated from Respondent's nomination papers).

16. Respondent's nomination papers contained a total of 5 signatures with insufficiencies pursuant to Wis. Admn. Code EL §§ 2.05-2.07 and Wis. Stat. § 8.15, *et. seq.*, bringing the total number of valid signatures below the threshold of 200 signatures necessary to be placed on the ballot for State Assembly. The contested signatures are contained in the above-referenced exhibits, accompanied by a detailed explanation of their insufficiency.

17. Complainant respectfully submits that the foregoing facts warrant the Commission's attention, and the Commission should take prompt action to eliminate from the nomination papers filed by Respondent all pages that are insufficient or do not comply with Wis. Admn. Code EL §§ 2.05 - 2.07.


18. Complainant reserves the right to amend this complaint with additional information.

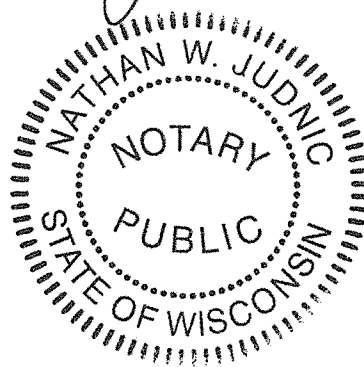

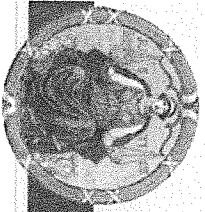

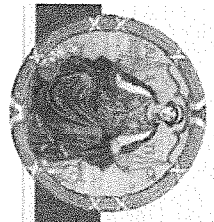
