Barring any unforeseen court action, Tuesday, July 12, 2011 has been set for holding all recall elections. The Government Accountability Board will meet on May 23 and May 31 to consider the sufficiency of recall petitions, and will make decisions accordingly. If there is not a legal challenge to the Board's decision, recall elections could be held in the following counties on July 12:
