


CAMPAIGN FINANCE CHECKLIST NON-CANDIDATE COMMITTEES & INDEPENDENT EXPENDITURE REGISTRANTS



SPECIAL ELECTION GOVERNOR, LT. GOVERNOR & SENATE DISTRICTS 13, 21, 23, AND 29

Campaign Finance Reports may be submitted to the Government Accountability Board, Ethics and Accountability Division electronically (<http://cfis.wi.gov>), by mail (P.O. Box 7984, Madison, WI 53707-7984), or in person (212 E. Washington Avenue, 3rd Floor, Madison, WI).

If not eligible for exemption from reporting requirements:

- ✓ Complete and submit a *Special Pre-Primary Campaign Finance Report (Form GAB-2S)* to the Ethics and Accountability Division no later than **April 30, 2012**. This report covers activity from January 1, 2012, or the date of your last report, through April 23, 2012.
- ✓ ** Please contact Rich Bohringer (608) 267-7735 **before April 23rd** if you have transactions in the CFIS reporting system that need to be moved from the July filing period into the Special Pre-Primary filing period.**

- ✓ Contact the Ethics and Accountability Division if your committee or registered group will be involved in the recall effort against Senator Bob Jauch. (608) 266-8005

- ✓ Complete and submit a *Special Report of Late Contribution (Form GAB-3 or GAB-4)* and/or *Independent Disbursement Report (GAB-7)* to the Ethics and Accountability Division within 24 hours of the receipt or disbursement from April 24, 2012, through May 8, 2012.

- Complete and submit a *Special Pre-Election Campaign Finance Report (Form GAB-2S or GAB-10)* to the Ethics and Accountability Division no later than **May 29, 2012**. This report covers activity from April 24, 2012, through May 21, 2012.

- Complete and submit a *Special Report of Late Contribution (Form GAB-3 or GAB-4)* and/or *Independent Disbursement Report (GAB-7)* to the Ethics and Accountability Division within 24 hours of the receipt or disbursement from May 22, 2012, through June 5, 2012.

- Complete and submit a *July Continuing 2012 Campaign Finance Report (Form GAB-2S or GAB-10)* to the Ethics and Accountability Division no later than **July 20, 2012**. This report covers activity from May 22, 2012, through June 30, 2012.
