The individual who requested I sign, did not tell me that the document was part of an effort to have a recall election ordered for Senator Wirtch. Instead I was told [led to believe] that the purpose of the document was to remove Walker
5. Had I not been misled about the purpose of effect of the petition, I would not have signed it. I do not and have not supported efforts to have a recall election held for Senator Wirtch's seat.


