



Having later realized my mistake I returned to the polling place with a Deputy Sherriff and requested that my name be removed. Gloria Towns told me that she did not believe it was legal to remove my name. I was able to have my name removed from the petition.
5. Had I not been misled about the purpose of effect of the petition, I would not have signed it. I do not and have not supported efforts to have a recall election held for Senator Hansen 's seat.

Megan Kuenl, being first duly sworn on oath, deposes and states as follows:

1. I an adult resident of the 1st State Senate District and I am a qualified elector, i.e., either registered to vote or eligible to register and vote.

2. On \_\_\_\_\_ at \_\_\_\_\_, I spoke with an individual who was soliciting passersby to sign a document.

4. On April 5th, 2011 during the election, my friend Jesse and I were on the sidewalk in front of Green Bay Community Church in Green Bay, WI. Also present were three individuals collecting recall signatures. A WWII Veteran returned to the church, escorted by a Brown County Sheriff's Deputy, and asked to remove his name. The workers had asked him to sign to "keep Senator Hansen on the ballot." The workers argued the legality of the removal of his name, argued with him, and called him names. His name was eventually removed but he was very shaken and agitated. →

5. Had I not been misled about the purpose or effect of the petition, I would not have signed it. I do not and have not supported efforts to have a recall election held for Senator \_\_\_\_\_'s seat.





Jesse Rouse of 812 Cora Street, Green Bay, WI being first duly sworn on oath, deposes and states as follows:

1. I am an adult resident of the 30 State Senate District and I am a qualified elector, i.e., either registered to vote or eligible to register and vote.
  
2. On April 5th, 2011 during the election, my friend Megan and I were standing on the sidewalk of Green Bay Community Church in Green Bay, WI. While there, several individuals were collecting signatures for their recall efforts. A WWII Vet (William Compton) came back to the recall workers (Ruben, Loren Olejniczak and Gloria Towns) and asked to have his name removed from the petition. Mr. Compton was escorted by a Brown County Sheriff's Deputy. The man approached the workers to have his name removed. When there, the workers told the man that they didn't know if it was legal to have his name removed. After several minutes, the man did scratch out his name. As he was ready to leave them, the workers were arguing with him and calling him names (senile, old, he has dementia). The man came by Megan and me and told us what happened. He told us that when he voted earlier, the workers asked him to sign the petition "to keep senator Hansen on the ballot". He was very shaken and very agitated. Ruben came over by us and stated that he did say that he said it was just to put him on the ballot.
  
3. On April 7th: my friend Lucy Bunker and other friends went to see Jerry Seinfeld at the Weidner Center tonight. We were approached to sign a document By Karen Garr. She told us it was to "get Dave on the ballot."
