Observer questioned the voting equipment tamper-evident seal numbers written on the EB104. White-out used to re-write numbers. There were more seal numbers than usual. The City of Mauston is the only municipality in Juneau County that uses TSX machines and OCR machine.

Telephone call made to City of Mauston Clerk. She explained that two seals are needed for each TSX machine. An extra seal was needed for TSX machine #1 as the tape was replaced. All seal numbers were recorded.

Ballot Container Tamper-evident seal noted on EL101 and EL104 63322. Ballot Bag opened. Machines TSX #1 and TSX #2 ballots were cut, stacked and counted.. OSR ballots were stacked and counted.

The ballots from the OSR machine were counted and then again counted due to the difference in the Trump and Write-In numbers. Several write-in ballots were placed in the Trump stack of ballots. Numbers were reconciled.

The Clerk was again called to explain the difference in Cancelled Ballots and Rejected Ballots on the TSX machines.. A Cancelled ballot is not printed on the tape. A Rejected ballot is printed on the tape and replaced by another ballot so only the second ballot is counted.


