VERIFIED COMPLAINT OF NICHOLL CARUSO

The Complainant, Nicholl Caruso, by Maistelman & Associates, LLC, her attorneys, alleges and shows as follows:

1. The Complainant, Nicholl Caruso (“Complainant”), is an elector of the State of Wisconsin residing at 1625 Kings Mill Way, #309 in Madison, Wisconsin.
2. The Respondent, Paris Procopis (“Respondent”), is an individual who purports to reside for voting purposes at 2435 N. 70th Street, Wauwatosa, Wisconsin.
3. Upon information and belief, on or about July 13, 2010, Respondent filed nomination papers for the Fall 2010 election for the office of Representative of Wisconsin 13th State Assembly District. The nomination papers allegedly consisted of a sufficient number of papers so as to exceed 200 (two hundred) signatures, the amount required for a candidate’s placement upon the ballot in such election. A typical nomination paper of Respondent is attached hereto as Exhibit A.
4. Upon information and belief Respondent’s nomination papers were circulated between June 1, 2010 and July 13, 2010.

CHALLENGES TO INDIVIDUAL SIGNATURES

5. The nomination papers filed by Respondent are defective for the following reasons:

- A. Respondent's Page 23 (two signatures on page) does not have the year of signing for each signature.
- B. Respondent's Page 21 line 10 (dated 7/12) is same as Becker Page 5 line 4 (dated 7/5) - duplicate signatures of Chris Bartholf.
- C. Respondent's Page 15; line 6 – Address is out of 13th District. *See* attached print out from Voter Public Access Database. Address is in the 12th Assembly District. *See* attached Affidavit of Wauwatosa City Clerk Carla Ledesma.
- D. § GAB 2.07(3)(b), Wis. Admin. Code, provides:

If a challenger establishes that an elector signed the nomination papers of a candidate more than once or signed the nomination papers of more than one candidate for the same office, the 2nd and subsequent signatures may not be counted. The burden of proving that the second and subsequent signatures are that of the same person and are invalid is on the challenger.

The following signatures should be removed from Respondent's Nomination Papers based upon § GAB 2.07(3)(b), Wis. Admin. Code:

- D1. Cullen page 5, line 7 (dated 6/5) is same as Procopis pg. 5, line 7 (dated 7/1). *See* attached Affidavit of Les Johns.
- D2. Cullen page 5, line 9 (dated 6/5) is same as Procopis pg. 5, line 9 (dated 7/1) *See* attached Affidavit of Les Johns.
- D3. Cullen page 6, line 1 (dated 6/5) is same as Procopis page 11, line 9 (dated 7/12) *See* attached Affidavit of Les Johns.
- D4. Cullen page 6, line 4 (dated 6/5) is same as Procopis pg. 5, line 4 (dated 7/12) *See* attached Affidavit of Les Johns.
- D5. Cullen pg. 6, line 8 (dated 6/5) is same as Procopis pg. 16, line 5 (dated 7/10) *See* attached Affidavit of Les Johns.
- D6. Cullen page 25, line 1 (dated 6/13) is same as Procopis pg. 13, line 1 (dated 7/12) *See* attached Affidavit of Les Johns.

CONCLUSION

Accordingly, Respondent has not been properly nominated as a candidate in the Fall, 2010 election for the office of Representative of Wisconsin 13th Assembly District and Respondent's name should not be placed upon the ballot in such election.

6. This Verified Complaint is made pursuant to § GAB 2.07(1), Wis. Admin. Code, and § 8.07, Wis. Stats.

WHEREFORE, Complainant respectfully requests that the State of Wisconsin Government Accountability Board (the "GAB") conduct an investigation pursuant to § GAB 2.07(5), Wis. Admin. Code, in conjunction with such other public officials as the GAB, or the Executive Director thereof, may deem appropriate, and determine the nomination papers of the Respondent to be insufficient for the reasons set forth in this Verified Complaint; and further, that the Respondent be denied placement on the ballot for the office of Representative of Wisconsin 13th Assembly District in the Fall, 2010 election.

1. That I am an adult resident of the State of Wisconsin and that I am a private detective licensed by the State of Wisconsin with license # 11619-063 and that I own and operate a licensed private detective agency known as L. Johns Services, LLC with license # 16747-062.

Spannuello identified his signature on the nomination papers for Paris Procopis (“Procopis”) contained on Page 5, line 7 of the Procopis nomination papers signed on July 1, 2010, and additionally identified his signature on the nomination papers for David Cullen (“Cullen”) contained on page 5, line 7 of the Cullen nomination papers signed on June 5, 2010. Spannuello additionally acknowledged the dates of his signature on the nomination papers as being correct.

6. On July 15, 2010, I traveled to 2463A N. 70th Street and spoke with an individual who identified herself as Heather Bader. Bader identified her signature on the nomination papers for Procopis contained on Page 11, line 9 of the Procopis nomination papers signed on July 12, 2010, and additionally identified her signature on the nomination papers for Cullen contained on page 6, line 1 of the Cullen nomination papers signed on June 5, 2010. Bader additionally acknowledged the dates of her signature on the nomination papers as being correct.


