**RE: IN THE MATTER OF COMPLAINT by ANDREW DAVIS & THE REPUBLICAN  
PARTY OF WISCONSIN**

**I, Commander William Thomas Tucker, running as “Bill Tucker for Congress” as an Independent for the Office of United States Representative from the 1<sup>st</sup> District of Wisconsin take issue, exception and umbrage with the false “Certified” Claim of Andrew Davis..**

**1. If Complainant Davis, as he alleges, lives at 2525 South Shore Drive, Milwaukee (with no listed phone number at that residence) is factual, he has no standing to challenge a legitimate Candidate, such as the “Respondent” legitimate Candidate not in his Congressional District, whether a “qualified elector” or not, he is not an elector in Wisconsin’s 1<sup>st</sup> District, so I challenge him that he has no standing to bring such false allegations.**

**2. Given.**

**3. Inaccurate. I filed the first of my Nomination papers on July 1, 2010, and a second batch on July 14, 2010...an additional 41 signatures, certified by the United States Postal Service.**

**4. Given.**

**5. Complainant Davis is inaccurate in stating that Respondent’s Nomination papers do not “Respondent’s name of municipality”. It most clearly states, both in the Heading boxes where called for and in the “Statement of Residence” at the bottom of each and every Nomination paper the Address and City of New Berlin where called for.**

**6. Complainant Davis fails to substantiate his false claim of said papers “are misleading and not in substantial compliance”, unless the foregoing false claim is his supposed “evidence” of same, which is moot.**

**7. Denied.**

**8. - 69. Respondent Tucker accepts the findings of signatures outside of District 1 and are therefore invalid, and not to be counted toward the 1,000 minimal required signatures.**

**70. Acknowledged, with exception to paragraphs 1 through 7, as noted above.**

71. Given.

72. Complainant is mistaken in his false allegation that the date on page 27, line 3 as to the date being written as "6/17" when in actuality it is written "6/12". My evidence is as follows: (1) as the balance of the gentleman's signature indicates, he has a very stylistic handwriting; (2) I was there and witnessed his signature at the time my son Matthew Tucker solicited it, and do attest as to his intent in signing on the correct date, as can my son who acquired the signature; (3) as evidenced by the fact that the preceding and following signatures are also date "6/12", and, in point of fact, the vast majority of signers looked to the date above to get their date correct. Complainant's attempt to discredit Candidate Respondent is a shameless, spurious, and malicious attack without foundation.

**RESPONDENTS FURTHER EVIDENCE:**

1. Respondent calls the Board's attention to the fact that Complainant Davis' review of Candidate Tucker's submitted Nomination papers is incomplete inasmuch as he did not review all of Candidate Tucker's submitted Nomination papers on time. An additional 41 signatures were submitted on July 14, 2010, of which it is admitted by Respondent that 7 live outside of District 1, but 25 are residents of District 1 -- the proof is herewith submitted with this document -- and 9 are questionable because the State cannot identify who their Representative is, and the benefit of the doubt should be given to the Signatories themselves as they are most likely to know who their Representative is.

2. Nonetheless, if one subtracts the 60 challenged signatures, that are admitted from the original total of 1,047 accepted and qualified by the Government Accountability Board in certifying Respondent Commander Tucker for the ballot, that leaves a net of 987 acceptable signatures. When one adds the bona fide 25 additional signatures submitted on July 14, 2010, the total comes to 1,012, more than the minimum required to be included on the ballot for the November election. If the Board decides to grant the 9 signatories the likelihood that they know who their Congressman is, and they vehemently stated that they are opposed to Incumbent Paul Ryan as their Representative, that brings Respondent Tucker's total signatures to 1,021. But that total is moot in any event as Candidate Tucker has met the Government Accountability Board's minimum required 1,000 signatures.

Now therefore, Respondent pleads with the Government Accountability Board to set aside this spurious and unfounded Complaint on Respondent's legitimate Candidacy for Public Office, and begs the Board to CENSURE Complainant Andrew Davis, and revoke his qualifications as an elector in the State of Wisconsin.
