## **Election of Presidential Electors**

NOTICE IS HEREBY GIVEN that at an election to be held in the several cities, villages, towns, wards, and election districts of the State of Wisconsin, on November 5, 2024, ten electors for President and Vice President of the United States, one for each congressional district and two for the state at-large, are to be elected. The names of presidential electors do not appear on the ballot, but each vote cast for a presidential candidate is a vote for the electors of the candidate. Independent candidates for President or Vice President may circulate nomination papers beginning July 1, 2024, and must file nomination papers with the Wisconsin Elections Commission no later than 5:00 p.m. on August 6, 2024. The Wisconsin Elections Commission is located at 201 W Washington Avenue, 2<sup>nd</sup> Floor, Madison, Wisconsin.

The first day to circulate nomination papers is April 15, 2024, and the final day for filing nomination papers is 5:00 p.m. on Monday, June 3, 2024. Candidates for constitutional, congressional, and legislative officers file with the Wisconsin Elections Commission. All county partisan office candidates file with their respective county clerk. Congressional and legislative district boundaries are described in Chapters 3 and 4 of the Wisconsin Statutes by 2023 Wisconsin Act 94, which is available at: <https://docs.legis.wisconsin.gov/2023/related/acts/94>.
