Members of the public who wish to speak should email electioncomments@wi.gov by 4:30 p.m. Thursday, July 21, 2022 with the words "Request to Speak" in the subject line. In the body of your email, you must provide:

- 1. Your name
- 2. Your telephone number
- 3. An indication of whether you'll be joining via Zoom or calling in via telephone
 - a. If you are joining via Zoom, your name as a Zoom attendee must appear the same as the name you provide in this email.
 - b. If you are joining via phone, your phone number must appear the same as the phone number provided in this email.

It is the speaker's responsibility to ensure that the name or telephone number listed for them as a Zoom attendee exactly match the name or telephone number that was provided to us. Failure to do so may prevent those individuals from having an opportunity to speak entirely.
