#### **VERIFIED 5.06 COMPLAINT**

#### **INTRODUCTION**

Complainant Jay Stone alleges Wisconsin Elections Commission (WEC) Staff Attorney

Angela Sharpe intentionally delayed the noticing of his Jay Stone v. **Second Starpe** for seven weeks. There are too many Sharpe contradictions, changes in story, and omissions for the seven week delay to be simple mistakes. Some of Sharpe's abuse of her election official discretion are as follows:

• Sharpe conveniently forgot to tell complainant that she did not receive his refiling of his complaint for several weeks. (Exhibit 7)

- Sharpe blamed Complainant for not refiling his complaint though it was untrue.
- Sharpe falsely claimed the Complainant's file size of his complaint as the potential reason the WEC did not receive his complaint (Exhibit 8)
- Sharpe said that after checking the WEC system she could not find Complainant's complaint. (Exhibit 8)
- After Complainant provided proof of him refiling his **complaint**, Sharpe admitted the system received his complaint on the August 3, 2024 date as the complainant stated. (Exhibit 8)

- Sharpe said we were not able to confirm what happened to Complainant's August 3, 2024 complaint after he filed it. (Exhibit 8)
- After Complainant said he may file a WEC complaint, Sharpe acknowledged that the Complainant submitted his complaint when he said he did.
- Sharpe blamed the seven week delay on the legal team not receiving Complainant's complaint on August 3, 2024. (Exhibit 8)

The timeline below outlines how Sharpe abused her election official discretion and

power. The timeline also includes Sharpe's contradictions and false claims.

Comment	Sharpe's July 26 and August 2 emails contradict each other. In Sharpe's July 26 email she said she sent the complaint via mail (Exhibit 1). In Sharpe's August 2 email she said FedEx was unable to deliver the complaint (Exhibit 3).	
August 3, 2024	Stone filed an open records request for the FedEx undeliverable complaint documents. (Exhibit 4)	
August 3, 2024	Stone refiled his complaint. (Exhibit 5)	
August 3, 2024	Stone refiled his complaint. (Exhibit 6)	
August 13, 2024	Sharpe confirms receipt of the complaint and said the respondents were noticed on August 9. (Exhibit 5)	

#### Timeline of the Angela Sharpe's Abuse of Discretion

September 26, 2024	Sharpe confirms receipt of Stone's complaint 7 weeks after he initially filed it. (Exhibit 8)
September 26, 2024 (8:59 AM)	Sharpe writes, "I checked through our system, and don't see that we ever received your email on 8/3/24. Maybe the size of the files prevented it from successfully entering our system at that time. (Exhibit 8)
September 26, 2024 (10:59 AM)	After Stone provided proof of his <b>and a</b> complaint submission to the WEC, Sharpe writes, "We looked into this matter, and it appears that while your 9:42 a.m. email from August 3 was received by our server on the backend, our Legal team never received it on the front end until you resent it this week. We were unable to locate it in our messaging system, and were also unable to confirm what happened to it." (Exhibit 8)
Comment	Sharpe's September 26, 8:59 AM email contradicts what she wrote in her September 26, 10:59 AM email. (Exhibit 8) At 8:59 AM Sharpe said, ""I checked through our system, and don't see that we ever received your email on 8/3/24." At 10:59 AM, Sharpe writes, "We looked into this matter, and it appears that while your 9:42 a.m. email from August 3 was received by our server on the backend, our Legal team never received it on the front end until you resent it this week."

#### SHARPE'S ALLEGED MISCONDUCT DESERVES A WEC INVESTIGATION

- Sharpe claimed that the legal team did not receive his WEC complaint on August 3, 2024.
   Sharpe's dubious statements raise more questions that demand answers:
  - When did the legal team receive the Complainant's August 3, 2024 complaint? If the legal team did receive Complainant's August 3, 2024 complaint on August 3, 2024, then Sharpe lied and intentionally delayed the notification of the Complainant's Jay Stone v.

respondents for seven weeks.

- Who is responsible for notifying the legal team of a WEC complaint submission? The person responsible for notifying the legal team of a WEC complaint can answer questions and provide additional information about the Complainant's August 3, 2024 complaint.
- If the legal team wasn't notified of Complainant's August 3, 2024 complaint on August 3, 2024, why wasn't the legal team notified?
- Why did Sharpe wait seven weeks to notify Complainant that she did not receive his refiled complaint? What changed for Sharpe that she suddenly contacts Complainant to tell him he did not resubmit his complaint?
- Sharpe contradicted herself when she said the Complainant's complaint was both mailed and sent by FedEx.
  - How did Sharpe attempt to notify the **complaint respondents**? Complainant filed an open records request for the receipt of the attempted delivery.
  - Has the WEC retained a copy of FedEx's unsuccessful delivery notice?
  - What is written on the unsuccessful FedEx delivery notice?
- 3. Sharpe conveniently said she forgot about the Complainant's complaint for several weeks.

- Did Sharpe use the WEC's complaint tracking software?
- If Sharpe did not use the WEC's complaint tracking software, why didn't she use it?
- If Sharpe did use the WEC's complaint tracking software, what information about Sharpe and the Complainant's and complaints are on the WEC's complaint tracking

software?

Wherefore the complainant asks the Commission to Order the following:

A. An investigation of Angela's Sharpe's handling of the Jay Stone v. and WEC complaints. Jay Stone v. B. Because of the impending November 5, 2024 election, Complainant requests expedited hearings for both the Jay Stone v. and Jay Stone v. WEC complaints. C. If the Commission determines Angela Sharpe mishandled or misrepresented the processing of the Jay Stone v. or Jay Stone v. For both complaints, you provided the same address for all identified Respondents:

For EL 73-24, the Commission sent a notice letter and a copy of that complaint on Friday, July 26, with a requested delivery of Saturday, July 30. From July 30 to August 1, the carrier, FedEx, attempted to deliver the notice package to that address every day, but were unsuccessful. Finally, FedEx alerted us this morning that the package could not be delivered to that address.

The Wisconsin Elections Commission ("the Commission") acknowledged your public records request on August 5, 2024. You sought the receipts, notices, communications for the unsuccessful 2024 FedEx delivery of the Jay Stone v. and Jay Stone v. and Jay Stone v. and Jay Stone v.

First, there are no responsive records for the Jay Stone v. **Complaint**. As I informed you, we were not able to notice that complaint because it contained the same undeliverable address as your first Stone v. **Complaint**.

Second, there are responsive records for your first Stone v. **Complaint**, but state law directs me to withhold those records pursuant to Wis. Stat. 5.05(5s). Specifically, that provision states that "[r]ecords obtained or prepared by the commission in connection with an investigation, including the full text of any complaint received by the commission, are not subject to the right of inspection and copying under s. 19.35(1)," subject to enumerated

exceptions. The records you seek constitute records "obtained or prepared by the commission in connection with" your complaint. The records you seek do not fall within any of the exceptions listed in Wis. Stat. 5.05(5s)(a) - (f), so I am not able to release them as public records.

To the extent that this response denies any part of your public records request, the WEC's determination is subject to review in an action for mandamus under Wis. Stat. § 19.37(1), or by application to a district attorney or the Attorney General.

For both complaints, you provided the same address for all identified Respondents:

EL 73-24, the Commission sent a notice letter and a copy of that complaint on Friday, July 26, with a requested delivery of Saturday, July 30. From July 30 to August 1, the carrier, FedEx, attempted to deliver the notice package to that address every day, but were unsuccessful. 


