On November 8, 2023, I received a letter from Donna Cox, the Germantown WI municipal clerk. And, if I did not return the form by Dec. 8, 2023, my absentee application will be deactivated.

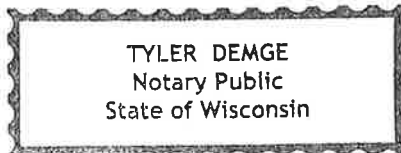

Voters that mark themselves as being Indefinitely Confined are certifying that due to age, illness, infirmity, or disability that he or she are unable to go to the polls on election day and wish to participate in all future elections by absentee ballot.

Indefinitely Confined electors will automatically receive an absentee ballot for all future elections until the elector requests to no longer receive them, fails to return them, relocates, or becomes deceased.

Indefinitely Confined electors are not permitted to vote in-person at the polls on Election Day or early absentee vote at Village Hall or other designated location as this will cancel the Indefinitely Confined status.

In an effort to keep our voter records current and in preparation of the 2024 Election Cycle, please indicate your absentee voting status below by checking the correct box and return this form to our office **NO LATER** than **December 8, 2023**. If our office does not receive the form below by the deadline, your absentee application will be deactivated.

If you have moved out of our jurisdiction or to a new address in the Village of Germantown since your last application – you will need to re-register at the new address and re-submit your request for an absentee ballot.
