Allegations

For the 2/18/2025 primary election and the upcoming 4/1 election, I was told by the other SVDs that Linda Gourdoux, the current Waukesha Interim City Clerk, said we did not have to go the the rooms of the electors to verify when they decline to vote. Per her instructions, we are supposed to accept the word of the Activity Director when residents decline to vote.

On February 3, while serving as an SVD at the Mission Creek facility, I told the other SVD that this instruction was not according to Wisconsin election law. We only had one resident who declined to vote. We both went to the room of that elector and verified their intent.

On 3/14/2025, I served as an SVD at the Oak Hill Terrace, 1805 Kensinton Dr in Waukesha. At 9am when I arrived I communicated my concerns to Mollie Schenk, who works under the Waukesha City Clerk, that SVDs are required by Wisconsin law to go to the room of the elector. She confirmed that Linda was instructing SVDs that they don't need to go to the rooms because it's too disruptive for the residents. Linda's response to my email, later on 3/14, gives further clarification of her instructions: "As a SVD is basically going into the voter's home, we are attempting to be as unobtrusive as possible. We are accepting staff word that a voter does not wish to vote because staff understands the residents better than we do. If the staff were telling a SVD to leave the ballot and they would have the voter complete later, this would not be acceptable. As long as the voter is not voting, telling staff works as well as leaving a memo."

This instruction is concerning because while I was at Oak Hill Terrace I was told by one of the electors that the residents were being given sheets of paper telling them who to vote for. The only sheets I saw from the residents simply stated what was on the ballot. I mentioned this to the elector. He said there were other sheets being handed out. I was not able to verify whether this was actually happening because I was working with other electors.

We were told that there were 29 electors who were declining to vote according to the staff member who was assisting us that day. I didn't get the name of this woman who works under the Activity Director Shelby T. We did not verify the electors who declined to vote on 3/14/2025.

But there is a revisit being scheduled for the electors who were not on site to vote. The SVDs who work at Oak Hill Terrace for the next visit should go to each electors' room to verify that they decline to vote.

On 3/14/2025, I signed the ballots and envelopes of the electors I assisted that day as an SVD. I objected and refused to sign the final SVD forms and the ballot bag because I do not agree with the instructions being given by Linda Gourdoux, the current Waukesha City Clerk.

As an SVD, I have taken an oath to follow Wisconsin election law, but Linda's directive is not following the law. SVDs are required to "seek the intent of the electors" and that we "shall personally offer each elector...the opportunity to cast his or her absentee ballot."
