I am concerned that no action has been taken by the Oak Creek-Franklin Joint School District Board of Education, its President, Mr. Frank Carini, or its appointed administrator, Superintendent Daniel Thielen, to rectify this situation.

I am further bringing to your attention my concerns that Mr. Krist's current position as Treasurer of the Oak Creek High School Robotics Booster Club, which publicly identifies the Oak Creek-Franklin Joint School District as a "sponsor," implicates state ethics provisions preventing conflicts of interest. The Board of Education is the governing body of the Oak Creek-Franklin Joint School District and is responsible for annual budgetary approval and financial disbursements. Mr. Krist's concurrent status as a Board member overseeing district funding disbursement and serving as treasurer of a district funding recipient raises concerns regarding the compatibility of these roles.

I am contacting you because the Board of Education and Board President Frank Carini have been apprised of these concerns yet have taken no action to ensure compliance with district policies governing the eligibility of Board members. Mr. Krist is a serving member of the Board of Education and a registered candidate for election to a full term and was recently certified for election as an eligible candidate. Earlier this month, following Mr. Krist's certification as a candidate, I submitted a communication to the Board of Education (See attached letter) noting these specific concerns, and to date, no publicly disclosed action has been taken, to my knowledge, to resolve these clear concerns surrounding Mr. Krist's eligibility for office.

Attached to this email are the notarized EL-100 Complaint Form, the letter that I sent to the Oak Creek-Franklin Joint School Board, and the email response I received from the Milwaukee County District Attorney's Office.

The Milwaukee County District Attorney's Office has received your complaint, emailed on January 31, 2025. I have reviewed that complaint. You raise concerns regarding Oak Creek-Franklin Joint School Board member Jerry Krist. In particular, you allege that Mr. Krist is in violation of Board of Education conflict of interest policies. You also raise concerns about Mr. Krist's role on the school board, as well as his role as the Treasurer for the Robotics Booster Club.

At this time, I am declining to commence an investigation. The District Attorney's Office's statutory mandate is limited to prosecuting crime. The facts that you recite do not allege any apparent criminal conduct. Ethical violations, by themselves, do not rise to the level of criminal behaviors. At this time, this office has no basis to take further action. Thank you for your time.

Oak Creek-Franklin Joint School District Board of Education

Policy 166: BOARD MEMBER CONFLICTS OF INTEREST

A board member shall not use his or her board position to obtain financial gain for or anything of substantial value for his or her private benefit or the benefit of his or her immediate family or an organization to which he or she is associated.

In the event a board member has a member of his or her immediate family who would receive a substantial direct or indirect benefit from a Board action, the board member shall declare his or her conflict of interest and refrain from debating or voting on the issue.

In the event a board member is employed by a corporation or business or has a secondary interest in a corporation or business which furnishes goods or services to the school district, the board member shall declare his or her interest and refrain from debating or voting on the question of contracting with the company. It is not the intent of this policy to prevent the district from contracting with corporations or businesses because a board member is an employee of the firm. The policy is designed to prevent placing a board member in a position in which his or her interest in the public schools and his or her interest in the board member's place of employment (or indirect interest) might conflict and to avoid appearances of conflict of interest even though such conflict may not exist.

No member of the Oak Creek-Franklin Joint School District Board of Education shall hold a position within the school district, regardless of the type or level of position or manner of pay. In addition, no board members shall hold two public offices if the two are deemed incompatible. The interests of the school district are best served when board members have no competing interests, positions or offices.

President Carini and Members of the Oak Creek-Franklin Joint School District Board of Education:

As a taxpaying resident of the Oak Creek-Franklin Joint School District and candidate for the Board of Education, I am bringing to your attention my concerns that Incumbent Board Member and Candidate Jerry Krist is ineligible to hold office as a member of the Board of Education due to an ongoing violation of Board policy. My concerns derive from the fact that Mr. Krist holds two positions in the Oak Creek-Franklin Joint School District in addition to his service as an appointed Member at Large of the Board of Education: Advisor of the Oak Creek High School STEM Club and Coach of the High School Robotics Team (note positions listed on Mr. Krist's LinkedIn page, <u>https://www.linkedin.com/in/jerry-krist-97a11a2b/</u>, with the notation "Contract").

Mr. Krist's continued service on the School Board while maintaining these positions constitutes a clear violation of Oak Creek-Franklin Joint School District Board of Education Policy 166, "Board Member Conflicts of Interest." Policy 166 is clear: "No member of the Oak Creek-Franklin Joint School District Board of Education shall hold a position within the school district, regardless of the type or level of position or manner of pay."

I am further bringing to your attention my concerns that Mr. Krist's current position as Treasurer of the Oak Creek High School Robotics Booster Club, which publicly identifies the Oak Creek-Franklin Joint School District as a "sponsor," implicates Policy 166 and raises significant concerns surrounding conflicts of interest. Member overseeing district funding disbursement and serving as treasurer of a district funding recipient raises significant concerns.

I emphatically support STEM and robotics programming within our schools and commend Mr. Krist for his involvement in and stewardship of these programs. However, for obvious reasons relating to objectivity and transparency in the allocation of taxpayer dollars, it is inappropriate for an individual involved in the management of district programs to serve concurrently on the Board, the entity with district budgetary oversight, in violation of existing policy.

The presence of such a conflict of interest requires action by the Board of Education to ensure compliance with district policies governing the eligibility of Board members. Mr. Krist is a serving member of the Board of Education and a registered candidate for election to a full term. If Mr. Krist is ineligible to serve on the Board given a conflict of interest, he should not be permitted to serve on the Board nor qualify for the ballot, and the Board should take immediate action to this effect.
