Allegations

Wis Stat . 8.05: A town can switch to using nomination papers and a nonpartisan primary election by either vote at a town meeting of the electors, or a referendum. The electors meeting vote could take place at any annual meeting or any special town meeting of the electors.

This was brought up at the April 16, 2024 Annual Voters meeting. From the minutes received from the clerk, there was a motion, and a second and a vote to switch from caucus to nomination papers. There was also a vote on the topic. This is where my concerns and complaints start.

State statutes that specifically regulate the conduct of the annual meeting of electors was not followed:

Wis, Stat 60.80: Requires that the clerk post or publish within 30 days, all resolutions, motions, or actions adopted at a town meeting. ##This was never done, see attached emails##

Wis Stat 60.14 was also not followed: According to the minutes received from the clerk. No record of means of voting was recorded or voted on. The number of people listed as attending the meeting does not match the recorded vote information regarding nomination paperwork. Attached minutes show that there are only 15 people listed as attending, and recorded 17 votes on this issue, (without even bring up the issue if they are eligible voters in the township)

I feel these clear violations of state laws specifically written in chapter 60 need to be addressed under Wis. Stat 8.05 because the meeting of electors have certain legal requirements. These requirements are what make these meetings the place to address issues that the town board alone can not take action on alone specifically Nomination paper work under Wis Stat. 8.05.

I have also attached a copy of a resolution the clerk presented at the December 2, 2024 regular board meeting to have the town board sign. Which was tabled because it was felt it was poorly written, and the clerk said, "it was no big deal they didn't really need it on file anyway." The town board is not allowed to make these changes on their own. I feel by allowing the Town specifically the Clerk to continue down this

path would create an illegal election come April 2025.

How would the citizens of my township know that they need to file nomination paperwork versus appearing at a caucus which has been the only means used since the conception of this township, and default by state law for small towns like ours? If someone would like to get on the ballot and know that we have always used caucus in the past. If they reach out in the beginning of January asking when the caucus is, and are told there isn't but you have until the 7th at 5pm to gather these signatures. Good luck!!

The township has a website with a calendar on it. www.fortwinn.com. There has never been anything on that as far as when nomination paper work would be available, when it can be signed, and when and whom it is due to, and when.

I have been researching this since the December 2nd 2024 meeting and spent an entire week corresponding with Jacob Walters (12/6/24-12/13/24) at the election commission after the Town Clerk told me to address the town board with any further questions. (see attached emails)

I have attached both email strings for public information requests for the Minutes and Postings of the annual meeting, including the agenda, Minutes, and resolution that was presented at the 12/2/24 board meeting.

So, my understanding is that there has never been a posting within 30 days of the annual meeting. That is correct. Like I previously told you, this is new to me. As you know, the previous clerk refused to provide any training to me, so I've been learning as I go and it hasn't been fun. You and your family haven't made it easy for a new clerk to come in and do this job. I tried to help out the town when they were in a pinch and you and your family have done nothing but made this job difficult. I only wish the next clerk gets treated better. That said, I did start a town update email and anyone wishing to receive information got it there. In the April email, I mentioned that it would be discussed at the Annual Town meeting and encouraged people to attend. In the May email update, I stated the results of the Annual Town meeting, that we would be going to Nomination Papers. So, maybe this counts as my posting? Not sure. I did the best I could to make anyone interested, know what was going on. I think if you asked anyone who wanted to know what is going on, that I've been very transparent and wanting to let everyone know what is going on, more than any other previous clerk. So, for you to say that I'm not doing my job, is insulting.

There was also no record of voting method. Names and address of electors present where not recorded. The number

of votes exceeds the number of electors present at the meeting. There were some that did not sign in, I only put the names in the minutes of those signing in. As you can tell, it was done by a hand count, thus the count shown in the draft minutes.



With out a posting or publication of meeting action. How are the citizens of the township suppose to know about nomination paperwork? See previous response above.

Having the town board adopt a resolution for nomination paperwork is beyond the powers of the town board. It was suggested by the WTA that we have a resolution on file, but it was adopted by the Annual Meeting, not the town board.

Switching between caucus and nomination paperwork can only be done via annual meeting or referendum. Yes, and it was done at the Annual Meeting.

Can you clarify how these "word of mouth" nomination papers are valid? If you attended the Annual Meeting, you would know that it is not word of mouth. It was acted on at the Annual Meeting. For this coming election?

If you have anything further, please take it up with the Town Board.

- 3. The town clerk shall properly post this resolution as required by law under Wis. Stat. ss 60.80(1)(a) within 30 days after its adoption.


