



The final estimate of the January 1, 2023 population for the Village of Kronenwetter in Marathon County is 8,539.

Approximately 6,529 of the estimated population for the Village of Kronenwetter are of voting age. This approximation is a courtesy estimate that helps you comply with Wisconsin Statute 5.66, which requires municipal clerks to approximate the number of electors prior to elections. The voting age population was calculated by applying the 2020 Census proportion of persons age 18 and over to the final January 1 estimate, and then multiplying the result by a statewide factor to account for the general aging of the population. Please note that, if you have an adult correctional facility in your municipality, its population is included in this voting-age estimate.

Ms. Hadley,

I do have concerns. Concerns with your reply email. You indicated, "We did speak with several people that felt the Clerks call was less than congenial, they then decided they would not continue working at the polls." No party names were <u>ever</u> called by telephone by me. If a call was made, it was made <u>after</u> I received their emails indicating they were not interested in becoming a poll worker or they indicated they told your party they were not interested and placed on the list regardless of their decision. So indicating these party names changed their mind due to my calling and them feeling I was less than congenial is not at all truthful and I take offense to that.

The resolution I drafted indicated all names that were submitted to me, via postal mail, by your party minus the three emails I received and attached indicating they did not wish to be on the list of election inspectors for the Republican party.

I will get back to MY concerns as indicated in my original email. I never once mentioned any incidents with Dan Jolin or the Wysocki family indicating your response to my email is based on a conversation you have had with Trustee Ken Charneski. My concern was the Republican party list Trustee Charneski had gotten from your party was **not a match** to the

finalized list your party sent to myself and President Chris Voll in November 2023. The list you supplied Trustee Charneski included more names than what was sent to myself and President Chris Voll. I have again attached what I received in the mail versus what you supplied Trustee Ken Charneski with. You also indicated to me in your reply email, "We do not include people that do not want to work at the polls, have told us No ,and we include them anyway or are placed on our list without their knowledge. It simply does not happen." The email sent from Mark Hoffman on December 01, 2023, reads otherwise.

You indicated you sent your submission out by post out on November 17 and I should have received it earlier than the date I stamped it received on November 30, 2023. It was stamped the date I opened it for receipt which was December 30, 2023. I am not sure why that was an issue that you had to point out.

I ask you rely your information and answers to me based on my questions and not what Trustee Ken Charneski has supplied to you or questioned to you. Wording you included in my reply did not even match anything I asked from your party in the first email sent on April 10, 2024.

If you have any concerns, I request you contact myself and not Trustee Ken Charnerski as he obviously does not have all of the correct information.

Chairman Hermening has received your email and has asked that I respond.

Your first question regarding Mr. Charneski.

Mr. Charneski sent me a copy of resolution 2023-016 appointing 2024-2025

election inspectors. That list contained 32 names both Republican and Democrats.

The Republican party submitted 21 names, your resolution indicated 18 Republican inspectors. Prior to sending our submissions we called each election

inspector, all 21 agreed to work. The Election Administration Manual indicates the Clerk contacts each party's nominees to confirm willingness to serve before submitting names to the governing body for appointment. Which you indicate you did. You did not Document nominees not willing to serve and provide that information to the Republican party. (Page 126 Election Administration Manual) We would have removed them from our list. The list that Ken sent to you was an early list in the making, not the final that was sent to you. We begin our calls in September, our lists change many times before they are submitted in final form.

All persons on our final submission to you were called. Everyone on our list was aware they were committed to the 24-25 election cycle. We do not place people on our lists without approval. We did speak with several people that felt the Clerks call was less than congenial, they then decided they would not continue working at the polls.

Wisconsin Statute 7.30(4)(e) indicates if a governing body has good cause not to appoint an individual whose name is submitted as a nominee, it may request the WEC to authorize a non-appointment and may Not decline to appoint such individual until receiving the WEC authorization. If you are removing people from our lists ,per statute, it must be reviewed by WEC.

I believe Mr. Charneski's concerns are based on incidents with Dan Joling and the Wysocki family. The Republican Party is not involved with that situation. We do not include people that do not want to work at the polls, have told us No, and we include them anyway, or are placed on our list without their knowledge. It simply does not happen.

Our submission was sent by post on November 17th, you should have received it prior to the November 30th date indicated on your letter of instruction.

That letter indicates per Wisconsin Statute 7.30(4)(b) if you do not intend to

Appoint all nominations you were to contact Chairman Hermening, that did not happen.

I also sent via email ,March 26,2024 ,an addition to our submission

Audrey Grey, you have not confirmed that appointment to date.

Please do so.

I will send an updated Election Inspectors Listing for your records
