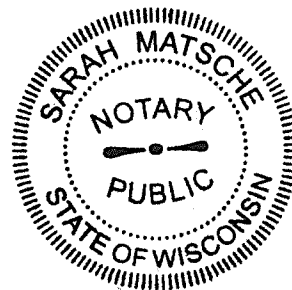

Response to s.5.06 Complaint Hadley v. Trueblood (EL24-96)

With regard to Kim Trueblood's Response :

Chairman Hermening's letter is not on Republican Party letterhead, is not the approved format, does not contain two signatures, was not presented to the Republican Party secretary for signature , was never presented to the Executive committee or the membership of the Republican Party for approval, And the signature is questionable in my opinion.

Chairman Hermening's letter also lacks a reason for the change and the removal of Ms. Leonard's name. One would think a reason would have been included in the letter of change at that late date.

I believe Deb Bouche's email dated June 11,2024 clearly implicates Clerk Trueblood's involvement in the selection of Deb Bouche as a candidate for the Board of Canvas. Clerk Trueblood" reached out to the cities Clerk's office to see if they knew anyone that could be a republican county canvas person". After that contact, Clerk Trueblood then contacted Deb Bouche regarding her interest. I believe that violates Statute 7.50(2) which requires the clerk to select Candidates for the county board of canvassers from the list provided by the Political party not to solicit candidates of her choice and then contact the Chairman for approval.

Clerk Trueblood neglected to mention that interaction in her response !

Clerk Trueblood also had two viable candidates from which to select a Canvas Member and yet she chose to call the city clerk's office and ignore Ms. Goergen and Ms.Olhoff's appointment ?

Clerk Trueblood, was involved in the placement of Deb Bouche on the Board of Canvas. The June 11th email clearly points to her involvement. Clerk Trueblood indicates this is an internal party problem, I believe her involvement contradicts that conclusion.
