Election inspectors count the votes at the polls on election night, but the official results of the elections are not determined until each official board of canvassers – for the municipality, county, state, school district, or other special purpose district – has met and completed the official canvass of their respective offices. This webinar will outline the canvass process for the Municipal Board of Canvassers (MBOC), discuss the composition of the MBOC and review canvass documentation. We will also provide some guidance for the County Board of Canvassers' process after an election.

A recount is the exclusive remedy to test in court the right of a candidate to hold office based on the number of votes cast at an election. This webinar will provide clerks with a general overview of recommended procedures, including who can request a recount, the timeline for a recount and sample forms for conducting a recount of an election result.
