We, the undersigned canvassers, certify the following is a true and correct statement for a special canvass regarding the November 5, 2024, General Election held in the City of Madison, Dane County, Wisconsin. The Board of Canvassers convened January 10, 2025, to tally ballots that were at the polling locations for Wards 56 and 65 on Election Day, but remained sealed in their carrier envelopes and courier bags, and were not processed at the polls. This includes 125 absentee ballots for Ward 56, 67 absentee ballots for Ward 65, and 1 absentee ballot for Ward 68 (sealed in the carrier envelope for Ward 65).





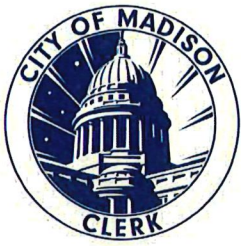
