To: Wisconsin Elections Commission

Re: Appeal to Filing Officer Decision in Nomination Paper Challenge

I, Scott Reed Beatty, filed a Nomination Paper Challenge with Town of Peshtigo Clerk Denise Wiedemeier on Friday, January 6, 2023 at which time she witnessed my signature, signed the document and stamped received. I initially presented to the Marinette County Clerk for filing, however, once it was determined that Clerk Wiedemeier would be at the Town Hall until 5 p.m. due to the filing extension for the Supervisor 2 seat, I made my way to file it directly with her.

In my filing ([Attachment A, pages 1-9](#)) I allege that nomination papers filed by Cindy Baur, candidate for Town of Peshtigo Supervisor 1, are insufficient based on Wis. Admn. Code EL § 2.05(14) which specifically states “no signature on a nomination paper shall be counted unless the elector who circulated the nomination paper completes and signs the certificate of circulator and does so after, not before, the paper is circulated” as well as Wis. Admn. Code EL § 2.05(15)(b) which states “an individual signature on a nomination paper may not be counted when the signature is dated after the date of certification contained in the certificate of circulator.” Pages 1 through 3 of Candidate Baur’s nomination papers include elector signatures with corresponding dates that are after the date of the circulator’s certification.

Additionally I reference the manual published by Wisconsin Elections Commission titled “*Nomination Paper Challenges*” dated January 2018 that includes prior Commission decisions on common challenges. On page 8 of the document the following example is provided:

*Challenge: The elector’s signature is dated after the date of the circulator’s certification.*

*Analysis: Staff has struck these signatures pursuant to the Commission’s administrative rules that provide that a signature may not be counted if it is dated after the date of the certificate of the circulator. Wis. Admn. Code EL § 2.05(15)(b).*

On January 9, 2023 I received email communication from Candidate Baur at 4:51 p.m. ([Attachment B](#)) that had her response to the Challenge attached. This attachment was initially scanned in to Clerk Wiedemeier’s email from a copier at the Town Hall at 3:43 p.m. and subsequently forwarded to Candidate Baur by Clerk Wiedemeier at 4:34 p.m. stating “Good afternoon Cindy I have sent this to the Wisconsin Elections Commission on Monday January 9, 2023.” I have attached a copy of an email sent by Deputy Clerk Kayla Okins ([Attachment C](#)) as evidence that “Copier ID #2753” as used in the Attachment B correspondence is indeed that of the Town Hall.

On January 12, 2023 I received an email from Clerk Wiedemeier ([Attachment D](#)) with her decision attached ([Attachment E](#)). Notice the attachment was also initially scanned in to Clerk Wiedemeier’s email from the copier at the Town Hall, Copier ID #2753.

I am filing an appeal to Clerk Wiedemeier’s decision as I allege there to be an abuse of discretion in her assertion that the paperwork filed on January 6, 2023 was incomplete as by her claim it was not “properly verified (Notarized or Sworn) as the challenge process in Administration Code EL 20.03 requires” as she states she “did NOT administer an Oath” and “simply stamped it ‘received’ and signed as is the policy” of the office.

As you can see the last statement on the filed Nomination Paper Challenge prior to my signature, which was witnessed by Clerk Wiedemeier at the Town Hall on January 6, 2023, states "I, Scott Reed Beatty, being first duly sworn on oath state that I personally read the above complaint, and that the above allegations are true based on my personal knowledge and, as to those stated on information and belief, I believe them to be true." In preparing my challenge I took that sentence directly from the Elections Commission Complaint Form EL-1100 which Clerk Wiedemeier directed me to in her decision. I know of no other Oath that Clerk Wiedemeier would have administered. When she signed Clarence Coble's Declaration of Candidacy for Town of Peshtigo Supervisor 1 (Attachment F) I do not know of an Oath that she would have administered at that time and yet the signature area of the Nomination Paper Challenge is essentially the same. My attempts to obtain a sworn affidavit of such from Candidate Coble have not been successful as he is in an RV in a desert in Arizona but did respond via message stating "Denise didn't give me an oath just signed Declaration of Candidacy papers with her watching and signing as deputy clerk. Never recited any oath to me. Signed as Clarence E Coble 1-15-2023." Mr. Coble stated you are welcome to call to verify the statement (715-587-1305). Regardless, it is my understanding and belief that there is no Oath to be given upon signature but rather the statement therein is the intended Oath and Clerk Wiedemeier's task was to sign the document asserting that she witnessed my signature on that date thereby declaring the stated Oath.

It is evident by Clerk Wiedemeier's signature on the filed Nomination Paper Challenge with the stamped date of January 6, 2023 (Attachment A, page 1) that she was in receipt of the paperwork on that date even if, unbeknownst to me, she signed on the incorrect line and did not indicate her Official Title as directed. Based on her personal relationship with Candidate Baur I do question if that misstep was intentional just as I find her decision completely without merit and have no other explanation as to why she would have ruled in such a manner other than her personal relationship with the challenged candidate.

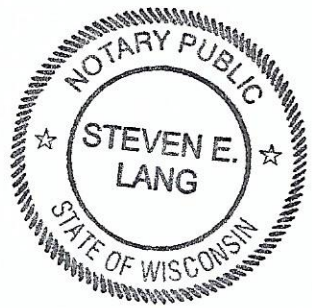

I, Scott Reed Beatty, allege that nomination papers filed by Cindy Baur, candidate for Town of Peshtigo Supervisor 1, are insufficient based on Wis. Admn. Code EL § 2.05(14) which specifically states "no signature on a nomination paper shall be counted unless the elector who circulated the nomination paper completes and signs the certificate of circulator and does so after, not before, the paper is circulated" as well as Wis. Admn. Code EL § 2.05(15)(b) which states "an individual signature on a nomination paper may not be counted when the signature is dated after the date of certification contained in the certificate of circulator." Pages 1 through 3 of Cindy Baur's nomination papers include elector signatures with corresponding dates that are after the date of the circulator's certification.

- Page 1 elector signature lines 2 through 10 have corresponding dates of 12/9/22 through 12/22/22 which are after the circulator certification date of 12/7/22.
- Page 2 elector signature lines 3 through 6 & 8 through 10 have corresponding dates of 12/19/22 through 12/23/22 which are after the circulator certification date of 12/1/22.
- Page 3 elector signature lines 2 through 6 have a corresponding date of 12/26/22 which is after the circulator certification date of 12/23/22.


The Wisconsin Elections Commission has published a manual titled "Nomination Paper Challenges" dated January 2018 that includes prior Commission decisions on common challenges. On page 8 of the document the following example is provided:

Challenge: The elector's signature is dated after the date of the circulator's certification.

Analysis: Staff has struck these signatures pursuant to the Commission's administrative rules that provide that a signature may not be counted if it is dated after the date of the certificate of the circulator. Wis. Admn. Code EL § 2.05(15)(b).

Additionally it should be noted that the candidate's residential address is missing on page 2.

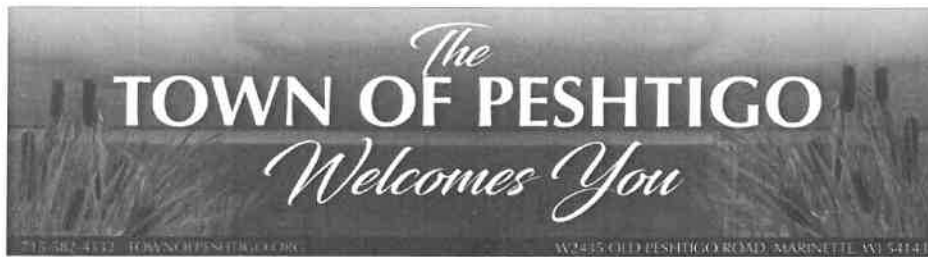
