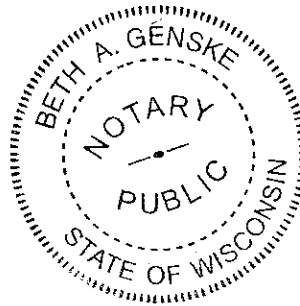

TO: WEC Board - Claire Woodall-Vogg of the City of Milwaukee Elections is failing to provide secure elections. She has a complete lack of comprehension of securing the computerized tabulators. Immediate action needs to be taken, today. Nov. 8<sup>th</sup>, 2022.

1 The ES&S tabulator computers she uses to conduct elections all use the same master election code password. And one master Administrative Code password. Thus, all 20 to 30 operators use the same password, for each of the tabulators. Whereby it would be impossible to know which specific person accessed which tabulator, at what time, and performed which changes to the machine. This is a horrible method of securing the tabulators where a nefarious change could be made on one or more tabulators, yet an auditor would never know who did it. Furthermore, with so many people having the password it could easily fall into the hands of an unauthorized person.

Relief: each ES&S tabulator must have its own password. Each poll worker or other person who does have authorized access must be assigned their own unique code number to access any tabulator.

2 Claire is not changing the passwords from election to election.

Relief: Each election the passwords for the tabulators and codes for the users must be changed to new, different ones.

3 ES&S set the master password, and it has not been changed. Or have not been changed recently.

Relief: The city of Milwaukee election commission panel should strictly control the passwords by creating them, and handing them out directly to each approved user. The panel must create new passwords for each new election. All software, including ES&S, has the ability to set up individual users with unique rights/access and secure passwords that are set by each user. This is the only way to be able to go back and audit who was on what machine and what specific things they did, including reports they accessed if there are questions.

4 It was just learned on the ES&S tabulators the Results Report can be accessed with the master admin password (even if mistakenly since it is located on the menu right above the Precincts Process Report which legitimately might need to be accessed). The results can be accessed during election day showing the running vote totals on those tabulators. If this is accurate, then right now 20-30 people can see the running vote totals on election days. This is an abhorrent lack of security. Is this true? Are all ES&S tabulators across the state like this? Please answer these questions today.

Relief: immediate changing of all the passwords, to individual specific ones. Immediately changing the access to that Results Report screen so it can only be accessed after the polls close. Reprogram the Results Report screen so two people must enter their passwords/codes at the same time. 1 Democrat, 1 Republican.
