VERIFIED COMPLAINT

Complainant Susan Trojan brings this Complaint against Respondent Claire Woodall-Vogg and Respondent Milwaukee Election Commission alleging as follows:

THE PARTIES

1. Complainant Susan Trojan is a registered voter and qualifies as an elector within the meaning of Chapters 5 and 6 of the Wisconsin Statutes. At all times relevant hereto, Complainant has resided and continues to reside in Milwaukee County in the City of Milwaukee, Wisconsin.

- 2. Respondent Claire Woodall-Vogg is the Executive Director of the Milwaukee Election Commission as set forth in Wis. Stat. § 7.21(2). Ms. Woodall-Vogg is an "election official" within the meaning of Chapters 5 and 6 of the Wisconsin Statutes.
- 3. Respondent Milwaukee Election Commission (the "MEC") carries out all powers and duties under chs. 5 to 12, Wis. Stats., pursuant to Wis. Stats. §§ 7.20 and 7.21. Claire Woodall-Vogg and the MEC are, collectively, referred to as "Respondents."

JURISDICTION

4. This suit is brought against Ms. Woodall-Vogg in her official capacity and the MEC under Wis. Stat. § 5.06 which provides that:

Whenever any elector of a jurisdiction or district served by an election official believes that a decision or action of the official or the failure of the official to act with respect to any matter concerning nominations, qualifications of candidates, voting qualifications, including residence, ward division and numbering, recall, ballot preparation, election administration or conduct of elections is contrary to law, or the official has abused the discretion vested in him or her by law with respect to any such matter, the elector may file a written sworn complaint with the commission requesting that the official be required to conform his or her conduct to the law, be restrained from taking any action inconsistent with the law or be required to correct any action or decision inconsistent with the law or any abuse of the discretion vested in him or her by law.

THE FACTS

- 5. Pursuant to Wis. Stats. § 6.855(1), the deadline for a governing body of a municipality to elect to designate an alternate absentee ballot site was June 9, 2022.
- 6. If the governing body of a municipality properly elects to designate alternate absentee ballot sites on or before June 9, 2022, that designation "shall remain in effect until at least the day after the election." Wis. Stat. § 6.855(1).
- 7. On June 1, 2022, the Milwaukee Common Council adopted Resolution 220149.

 A true and correct copy of Resolution 220149 is attached hereto as "Exhibit 1".
 - 8. On June 6, 2022, the Mayor of Milwaukee signed Resolution 220149.

- 9. Resolution 220149 lists 27 locations with addresses scattered across the City of Milwaukee. (Exh. 1). A map reflecting those 27 locations and City Hall is attached hereto as "Exhibit 2".
- 10. In July of 2022, Respondents posted a Type E Notice on the MEC's website, which is identified with the caption: "Voting by Absentee Ballot" ("the Notice"). A true and correct copy of the Notice is attached hereto as "Exhibit 3".
- 11. In relevant part, the Notice identifies four of the 27 locations listed in Resolution 220149 at which an elector might "request and vote an absentee ballot in the Election Commission during the days and hours specified for casting an absentee ballot in person." The four locations listed in the Notice are (i) Frank P. Zeidler Municipal Building; (ii) Midtown Center; (iii) Zablocki Library; and (iv) Good Hope Library ("the Four Locations").
- 12. The Notice indicates that electors may request and vote an absentee ballot at any one of the Four Locations at any point in time between Tuesday, July 26 and Saturday, August 6, 2022 during the hours of 9:00 a.m. to 6:00 p.m. on weekdays, and 10:00 a.m. to 3:00 p.m. on weekends.
- 13. The Notice also indicates that in-person absentee voting will be available at the remaining 23 sites from "August 1 5, 2022 by appointment only" and, furthermore, it instructs electors wishing to make such an appointment to email a request to wortening@milwaukee.gov. The Notice adds: "Please provide explanation for why the other sites with regular hours are not able to accommodate the voter." (Exh. 3).
 - 14. The Notice further indicates:

The first day to vote an absentee ballot with the clerk's office is:

Tuesday, July 26 at 9am

The last day to vote an absentee ballot with the clerk's office is:

Saturday, August 6 at 3pm

- 15. As the governing body of the City of Milwaukee, the Milwaukee Common Council has the power to designate a site other than the office of the municipal clerk or the board of election commissioners "as the location from which electors of the municipality may request and vote absentee ballots and to which voted absentee ballots shall be returned by electors for any election." Wis.Stat. § 6.855(1). The Common Council purported to act under this statutory authority when it adopted Resolution 220149 on June 1, 2022. (Exh. 1)
- 16. In mid-July, 2022—shortly after the Common Council adopted Resolution 220149—Respondents published the Notice on the MEC website.
- 17. In numerous respects, the Notice was inconsistent with, and contrary to, the requirements of Wisconsin law and Resolution 220149.

THE CLAIMS

- I. Respondents Are Not Authorized to Designate Alternate In-Person Absentee Ballot Voting Sites.
- 18. Only the Milwaukee Common Council has the authority under Wis. Stat. § 6.855 to designate alternate absentee ballot sites for in-person absentee ballot voting, as set forth in § 6.86(1)(a)(2) and § 6.86(1)(b).
- 19. Neither a municipal clerk or board of election commissioners has the authority to determine whether to use or not use an alternate absentee ballot site after properly designated by the Common Council.
- 20. Here, Respondents unilaterally determined which alternate absentee ballot sites would be used during the primary election on August 9, 2022; however, authority to unilaterally determine which sites would be used was neither granted by the Milwaukee Common Council nor is it authorized by Wis. Stat. § 6.855.

- 21. There is no authority for Respondents to determine what alternate absentee ballot sites will be used, or not used, which is exclusively granted to the Common Council. Likewise, there is no authority for Respondents to determine that alternate absentee ballot sites will be used in a manner not authorized by the Common Council.
- 22. Furthermore, Respondents were required to immediately display notice of the designations made by the Milwaukee Common Council, both in its office and on its website, beginning on June 1, 2022 through the period that absentee ballots are available for the election. Wis. Stat. § 6.855(2).
- 23. Respondents failed to post any such notice until July 2022, in violation of Wis. Stat. § 6.855(2).
 - II. The Alternate In-Person Absentee Ballot Voting Sites Are Not "As Near As Practicable to the Office of the . . . Board of Election Commissioners."
- 24. Pursuant to the controlling statute, alternate in-person absentee voting sites must "be located as near as practicable to the office of the municipal clerk or board of election commissioners...." Wis.Stat. § 6.855(1).
- 25. In this case, the 27 alternate in-person absentee voting sites that Respondents identified in the Notice are not "as near as practicable" to either the municipal clerk or the MEC, both of which are located in Milwaukee's City Hall at 200 E. Wells Street, Milwaukee, Wisconsin.
- 26. Attached hereto as "Exhibit 2" is a map of the City of Milwaukee. The yellow marker on the map is City Hall. The red and green markers on the map are the alternate absentee ballot sites identified by Respondent in the Notice.

27. There were many sites that Respondents could have designated that were closer to City Hall than the sites that Respondents included in the Notice. By failing to use only locations that were as "near as practicable" to City Hall, Respondents violated Wis. Stat. § 6.855(1).

III. By Allowing a Function of Absentee Ballot Voting at the MEC Office, Respondents Violated § 6.855.

- 28. Wis. Stat. §6.855(1) provides that, "no function related to voting and return of absentee ballots that is to be conducted at the alternate site may be conducted in the office of the municipal clerk or board of election commissioners."
- 29. While functions related to voting and the return of absentee ballots were being conducted at one or more of the 27 alternate in-person absentee voting sites identified in the Notice during the in-person absentee voting period prior to the August 9th primary, at least some of those same functions were being conducted in the office of the municipal clerk and/or the MEC.
- 30. The Notice plainly indicates that the first day "to vote an absentee ballot with the clerk's office" (emphasis added) was July 26 and the last day to do so was August 6. Plainly, between July 26 and August 6, absentee voting was ongoing at one or more of the alternate inperson absentee voting sites. Any absentee voting that may have taken place in the clerk's office or the MEC while at the same time absentee voting was occurring at one or more of the alternate in-person absentee voting sites is not permitted and violated Wis. Stat. § 6.855(1).
- 31. Additionally, during the July 26 to August 6 time period, electors were also permitted to deliver their absentee ballots to the MEC in City Hall, and a drop box was established in MEC's offices for that purpose, which is attached as "Exhibit 4" and depicted below:



- 32. During the same time period, electors were also permitted to drop off their absentee ballots at one or more of the alternate in-person absentee voting sites.
- 33. Since a "function related to voting and return of absentee ballots" occurred at an alternate in-person absentee voting site—for example, the return of completed absentee ballots—then allowing that same function to occur at the municipal clerk's office or the MEC violated Wis. Stat. § 6.855(1).

IV. In-Person Absentee Ballot Voting "By Appointment" Is Not Authorized by Law.

- 34. Nothing in Wisconsin law authorizes voting "by appointment," and Respondents' creation of that option in the Notice violates Wisconsin law. Furthermore, even if, *arguendo*, it is authorized by Wisconsin law, nothing in Resolution 220149 authorized voting "by appointment."
 - 35. Absentee ballot voting is strictly regulated in Chapter 6 of the Wisconsin Statutes.
- 36. The Legislature expressly stated in Wis. Stat. § 6.84(1), as the public policy of this State, that:

voting by absentee ballot is a privilege exercised wholly outside the traditional safeguards of the polling place. The legislature finds that the privilege of voting by absentee ballot must be carefully regulated to prevent the potential for fraud or abuse; to prevent overzealous solicitation of absent electors who may prefer not to participate in an election; to prevent undue influence on an absent elector to vote for or against a candidate or to cast a particular vote in a referendum; or other similar abuses.

- 37. Indeed, the requirements of absentee ballot voting are so stringent that, "with respect to matters relating to the absentee ballot process," any ballot "cast in contravention of the procedures specified in those provisions may not be counted" and "may not be included in the certified result of any election." Wis. Stat. § 6.84(2).
- 38. Nowhere in Wis. Stat. § 6.86 does the statute afford a municipal clerk or Election Commission the ability to conduct absentee ballot voting by appointment.
- 39. Likewise, there is no provision of the Wisconsin Statutes that allows a municipal clerk or Election Commission the ability to pick and choose which voters may qualify for "by appointment" voting and under what circumstances. Such a voting regime, with essentially no oversight or observation, results in the disproportionate and/or unequal administration of elections.

- 40. Additionally, pursuant to Wis. Stat. § 7.41, the public has an absolute right to access any polling place, municipal clerk office, or alternate absentee ballot site to observe the absentee ballot voting process.
- 41. Respondents' "by appointment" voting scheme further violates Wis. Stat. § 7.41 because it does not afford any opportunity for observers to reasonably access and observe such voting.
- 42. Furthermore, the "by appointment" scheme does not provide any meaningful notice to observers as to when an elector may vote by absentee ballot at an alternate site since the appointment is not noticed to the public in advance.
- 43. Notice of all absentee voting was to be posted by or before June 23, 2022, pursuant to Wis. Stat. § 7.15(1)(cm), which clearly did not and cannot occur for electors who may opt to vote "by appointment." Wis. Stat. §§ 6.855(2) and 7.15(1)(cm).
- 44. Respondents' "by appointment" absentee voting scheme is entirely outside of the safeguards intended to preserve transparent and fair elections.
- 45. Respondents' creation and implementation of "by appointment" voting not only violates Wisconsin law, but it puts absentee votes that may be cast in the fall election at great risk of not being counted.
 - V. Respondents Use of Certain Alternate In-Person Absentee Ballot Voting Sites Afford an Advantage to A Political Party in Violation of Wis. Stat. § 6.855.
- 46. Wis. Stat. § 6.855(1) states that, no alternate in-person absentee voting site may be established in a location that "affords an advantage to any political party." In this case, one or more of the 27 alternate absentee ballot sites identified in the Notice afforded an advantage to one political party over another political party.

- 47. Respondents have elected to designate one or more alternate in-person voting sites that afford an advantage to the Democrat Party.
- 48. For example, Resolution 220149 provides that the location of Good Hope Library, 7717 W. Good Hope Road ("Good Hope Site") will be an absentee in-person voting site for the Fall 2022 Election. The Good Hope Site was used as an in-person absentee ballot site from July 26 to August 6 for the primary election on August 9, 2020. (Exhibit 3).
- 49. However, the Good Hope Site is also, at least in part, staffed and used by Senator Lena C. Taylor (D Milwaukee, 4th Senate District) for office hours.
- 50. Furthermore, Senator Taylor has scheduled office hours from noon to 4 p.m. on November 4, 2022 at the Good Hope Site. (Exhibit 5).
- 51. Without question, Respondents intended use of the Good Hope Site, or any other site under similar circumstances, affords an advantage to the Democrat Party.

PRAYER FOR RELIEF

WHEREFORE, the Complainant requests the following relief:

A. That Respondents be directed to conform their conduct to the law as described above, be restrained from taking any action inconsistent with Wisconsin law (including Wis.Stat. §§ 6.86 and 6.855) as set forth above, and be required to correct the Notice and any other MEC notices, policies, procedures and communications that are inconsistent with applicable law.

B. That in the future—including during the 2022 general election—Respondents
Woodall-Vogg and the MEC be ordered (i) to locate any alternate in-person absentee voting sites
as near as practicable to the office of the city clerk or the MEC; (ii) to prevent any voting or
absentee ballot returning activities at the municipal clerk's office and at the MEC at any time
during which such voting or absentee ballot returning activities are permitted to be taking place

at any alternate in-person absentee voting site; (iii) to eliminate all voting "by appointment"; and (iv) to refrain from locating any alternate in-person absentee voting site in any location that confers a partisan advantage to any party.

C. Such equitable and other relief as is just and appropriate.



VOTING BY ABSENTEE BALLOT

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 28 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot. Proof of identification must be provided before an absentee ballot may be issued.

You must make a request for an absentee ballot in writing.

Contact the City of Milwaukee Election Commission and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also submit a written request in the form of a letter. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. You may make application for an absentee ballot by mail, email or in person.

Making application to receive an absentee ballot by mail.

The deadline for making application to receive an absentee by mail is: 5pm on Thursday, August 4, 2022

Note: Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.
