### RECALL PETITION

TO: Tony Decker Wrightstown Community School District Board Clerk (official with whom nomination papers or declaration of candidacy for the office is filed), We, the undersigned qualified electors of the Wrightstown Community School District (jurisdiction or district of officeholder) petition for the recall of Angela Hansen-Winker WCSD School Board President from office pursuant to Article XIII, Section 12 of the Wisconsin Constitution and § 9.10 of the Wisconsin Statutes. (name of officeholder to be recalled and office)

#### STATEMENT OF REASON FOR RECALL

(The reason for recall must be stated on petitions for city, village, town, and school district officials. The reason must be related to the official responsibilities of the officeholder. No statement of reason is required to initiate the recall of state, congressional, legislative, judicial, or county officials.)

Disregard for Board Procedures, Lack of Transparency and Communication, Conflict of Interest and Ethical Violations, Violation of District Policies and Code of Conduct.

THE MUNICIPALITY USED FOR MAILING PURPOSES, WHEN DIFFERENT THAN MUNICIPALITY OF RESIDENCE, IS NOT SUFFICIENT. THE NAME OF THE MUNICIPALITY OF RESIDENCE MUST ALWAYS BE LISTED.

For those of you that will be attending the school board meeting this evening. I just want to let you know that you DO NOT need to sign in unless you plan on speaking during open forum. We have had some issues with our president and vice president not following policy. At the last meeting they took a picture of the sign in sheet that had a board member's information on there and the one before that an employees personal information on it. I reached out to a lawyer at WASB (lawyers that are free of charge for board members to reach out to for legal advice). He did verify that this should not have been done and violates policy and potentially law. Because that personal information was on there, she is supposed to be following our policy and requesting those records. By doing this, it gives the district administrator the chance to retract the board member and employees personal information before giving her the list.
