## In Re: The Election for 2<sup>nd</sup> District Representative in the United States House of Representatives

Verified Petition

Petitioner Charity Barry alleges and shows to the Wisconsin Election Commission:

- 1. That Petitioner was a candidate for the office of Representative in the United States House of Representatives ("Representative") in an election held in the Second Congressional District of Wisconsin (the "District") on August 9, 2022; The Petitioner is the aggrieved candidate
- 2. That Petitioner is informed and believes that a mistake or fraud has been committed in the District in the counting and return of votes cast for the office of Representative; and
- 3. That the Petitioner is informed and believes that certain of the mail-in and walk-in ballots tabulated and counted in the District were defective and/or illegally cast and that the tabulated results are inaccurate.

Wherefore: Petitioner requests a HAND recount of the entire Second Congressional District including Dane, Sauk, Iowa, Lafayette, Green, and Rock Counties.
