Returned Absentee Ballot Statuses

Voter Request

- Voter contacts clerk **before ballot's returned**, and before end of absentee period, to request ballot be cancelled.

Voter Spoiled

- Voter contacts clerk **after ballot's returned**, but before end of absentee period, to request ballot be spoiled

Returned Absentee Ballot Statuses

Returned, to be Rejected

- Ballot's returned, but there's an unfixed, invalidating issue with it
- Not rejected yet

Rejected at Polls/MBOC

- Ballot's returned and rejected, due to an unfixed issue with it

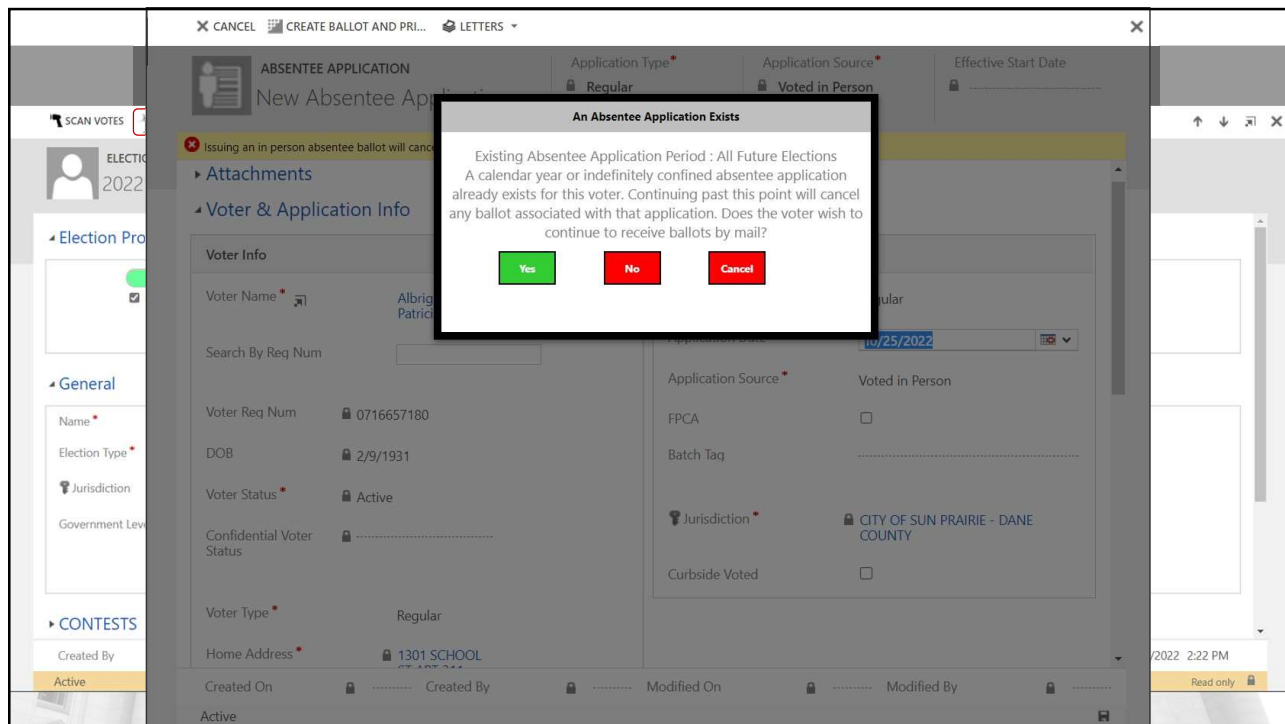
