The Complaint of JoAnna for Wisconsin, Complainant, against Enrique Murguia and Enrique for the People, Respondent, whose address is 111 E Seeboth St, Milwaukee, WI 53204.

The majority of this complaint is under 8.15(3) of State of Wisconsin statute.

All signers on each separate nomination paper for all state offices, county offices, and the offices of U.S. senator and representative in congress shall reside in the jurisdiction or district which the candidate named on the paper will represent, if elected.

I, Jackson Weber, representative of JoAnna for Wisconsin, allege, upon information and belief, that:

Of the nomination signatures turned in by Enrique Murguia, candidate for Representative to the Assembly, District 8, 63 of the Electors signed their Residential Address as an address that is outside of Wisconsin State Assembly, District 8. This is a clear violation under 8.15 (3). A map of Wisconsin State Assembly, District 8, is attached [Exhibit A]. A full list of the address violations and documentation of the Assembly District each address resides in as provided by the Wisconsin State Legislature's website, maps.legis.wisconsin.gov, is attached [Exhibit B]. All signatures from Electors outside of District 8 should be invalidated according to 8.15(3).

Additionally, the signature of Elector on Page no. 24, line 4, was completed on May 22nd, 2020, after the Circulator had signed that page on May 15th, 2020 [Exhibit C]. This signature should be invalidated.


Furthermore, seven Electors listed no Date of Signing or a completely illegible Date of Signing.

A full list of Date of Signing violations is attached [Exhibit D]. These signatures should be invalidated.

Finally, five Electors did not include their full name. Some included first name and last initial, others included first initial and last name. One signature not included in those was already invalidated by the Wisconsin Election Commission. A full list of Printed Name violations is attached [Exhibit E]. These signatures should be invalidated just like the one already was.
