In a partisan primary, electors vote by party to qualify candidates for the November General Election. Some voters may take issue with voting by party, rather than candidate, but Wisconsin's partisan primary has been in place since the early 1900s! This webinar will review the rules for counting votes in a partisan primary, the impact of selecting a party preference, overriding and remaking crossover and overvoted ballots and provide some new counting write-in votes scenarios just for this election!
