

# Reply to the Milwaukee Elections Commission's response Concerning the Complaints of the April 7th Election that took place

- 1. The City of Milwaukee Election Commission did not respond to the complaint of knowingly attempting to destroy election material. There is more than enough overwhelming evidence that shows this including a video of the act and the Chief Inspector Report that was furnished in the original complaint. The printing of a ballot machine tape was not in this formal complaint. Please refer to exhibit 1-3 of the original complaint that was filed.
- 2. The Milwaukee Election Commission is making the argument that they were proactively preventing jams from occurring by removing ballots from the machines. It was clearly stated in the Chief Inspector report that 2 ballot machines were emptied around 2 P.M. because they were at capacity. There was no mention of any jamming issues in the report. Capacity is 2,500 ballots per machine. If there were 5,000 ballots removed from 2 machines at 2 P.M. and the polling site was open for many more hours; it would lead a reasonable person to believe that there were many more ballots cast than the Milwaukee Election Commission has published. Wisconsin State Statute 5.02(15) is defined as follows: "Polling place" means the actual location wherein the elector's vote is cast. This definition clearly states that no ballots should have ever left the area where votes were casted. This would bring doubt in election integrity by most reasonable electors. Please refer to exhibit 1-2 of the original complaint.
