Dear Commissioners Findley, Cabrera and Ripp:

Enclosed with this letter, please find a sworn Wisconsin Statute § 5.06 complaint filed with our office from Jonathan Hunt, Wisconsin Voters Alliance. The complaint is related to a news article that reported voter registration counts in several City of Milwaukee wards and compares that information to unofficial election results from Tuesday's election in those wards.

As you may be aware, individuals that believe the actions of an election official were contrary to an election law or were an abuse of discretion in applying an election law may file a complaint with our office. To process this complaint, I ask that you provide a sworn written response to the complaint within 10 business days of receipt of this letter and complaint. Your response should address the allegations raised in Mr. Hunt's complaint.

After you file your response, Mr. Hunt is then afforded the opportunity to file a reply to your response within 10 business days of receipt of your response. Once all the allowable filings have been made, the Commission staff will review the information and draft a decision in consultation with the Commission Administrator. The
