Online Election Inspector Recruitment

The deadline to appoint election inspectors (a.k.a. poll workers) for the 2022-2023 term is quickly approaching on December 31, 2021. To help municipalities recruit and help build their pool of available election inspectors, the Wisconsin Elections Commission is happy to announce the ability to sign up as a poll worker on

When a prospective election inspector visits MyVote, they will see a promotion on the homepage letting them know the qualifications to become a poll worker and will be asked to enter their address. After entering in their residential address, they will be prompted to enter their name, phone number, and email address in a webform. Once submitted, an email with their information will be sent directly to their municipal clerk at the email address that is on file with the
