All signatures of 170 were found in accordance with the Law of the Milwaukee Election Commission is making up new rules only for me. I also believe they are being bribed because I presented video proof of other candidates leaving nomination papers unattended & forcing businesses to leave their papers unattended in counties and the Milwaukee Election Commission still certified these candidates for the ballot altho they engaged in election fraud & voter intimidation.

I submitted proof of 170 'postal addresses' located in the jurisdiction that it as a candidate seek to represent & the Milwaukee Election Commission ignored it & are trying to disenfranchise the will of the voters, no one challenged my signatures, & all nomination papers are in substantial compliance with the law.
