### Let's Train Some Poll Workers!

Now that election inspectors for the 2022-2023 election cycle have been appointed, there's never been a better time to train your new poll workers on the ins and outs of the polling place and election process.

To assist clerks in training their poll workers, the WEC has created a curriculum of video presentations that can be found in <u>The Learning Center</u>. The videos are based off of previously



created training agendas and split out by specific topic, and they can be accessed and watched whenever convenient for your poll workers. The poll worker agenda videos are a great resource for both new poll workers hoping to learn about their new position, and also for experienced poll workers that would like a refresher course ahead of the 2022 election cycle.

WEC has also updated the existing poll worker agendas that break down the various tasks that need to be done on Election Day and created a PowerPoint presentation for each one. These agendas and PowerPoint presentations are task-specific and cover a variety of topics that poll workers will need to know in order to successfully work at the polls. Each different polling place responsibility is broken out, so specific trainings can be used to provide training to the poll workers who will be responsible for that specific responsibility on Election Day. Clerks can use the PowerPoints or agendas during their own in-person trainings or refer poll workers to review them as necessary. Again, you can find these materials on The Learning Center and also on our agency website.

### Required Badger Book Update

An important update was launched recently for Badger Books across the State. This update is extremely important, and the Badger Books won't function without it. These instructions were emailed to all municipalities with Badger Books on January 6th, and can also be found on our TLC training home page. There you can also find information about what is included with this update and what you should expect after the update is completed. This update is required to maintain compatibility with WisVote data and must be installed before future elections.
