This complaint is made under Chapters 5 and 8 of the Wisconsin Statutes and Chapter GAB 2 of the State of Wisconsin Administrative Code, and requests that the Government Accountability Board review the sufficiency of the nomination papers for the Respondent in light of the allegations contained herein.

I, Andrew Davis, allege that:

1. I am a resident of the State of Wisconsin and am a qualified elector. I reside at 2525 South Shore Drive, Milwaukee, Milwaukee County, Wisconsin, 53207.
2. Andrew Wisniewski, who listed his address as 4423 Menasha Avenue, Manitowoc WI 54220 has filed nomination papers with the Government Accountability Board for certification as a Republican candidate for the Wisconsin State Assembly in the Twenty Fifth District on the November 2, 2010 ballot.

Signer Does Not Reside within the District


3. Complainant re-alleges and reincorporates herein paragraphs 1 through 2, above.
4. Section 8.15(3), Wis. Stats. states “all signers on each separate nomination paper...shall reside in the jurisdiction or district which the candidate named on the paper will represent, if elected.”
5. Chapter 4.005 of the Wisconsin Statutes provides a description of the 25th Assembly District. A residence falling outside of the description listed in Chapter 4.005, is not within the boundaries of the 25th Assembly District. Exhibit A is a map demonstrating the boundaries of the 25th Assembly District.

6. Page 1, line 8 of Respondent's nomination papers is signed by an individual who listed his/her municipality of residence as 14026 Hwy. Q, Maribel. A copy of page 1 of Respondent's nomination papers is attached hereto as Exhibit B. Exhibit B contains a printout of the Wisconsin State Legislative search for representative districts, and it clearly demonstrates that the residence is located in the 2nd Assembly District, not the 25th Assembly District, in contravention of section 8.15(3).
7. Page 5, line 9 of Respondent's nomination papers is signed by an individual who listed his/her municipality of residence as 5611 Thunder Rd., City of Manitowoc. A copy of page 5 of Respondent's nomination papers is attached hereto as Exhibit C. Exhibit C contains a printout of the Wisconsin State Legislative search for representative districts, and it clearly demonstrates that the residence is located in the 2nd Assembly District, not the 25th Assembly District, in contravention of section 8.15(3).
8. Page 16, line 2 of Respondent's nomination papers is signed by an individual who listed his/her municipality of residence as 1036 Mallard Ln., City of MTWC. A copy of page 16 of Respondent's nomination papers is attached hereto as Exhibit D. Exhibit D contains a printout of the Wisconsin State Legislative search for representative districts, and it clearly demonstrates that the residence is located in the 2nd Assembly District, not the 25th Assembly District, in contravention of section 8.15(3).
9. Page 16, line 7 of Respondent's nomination papers is signed by an individual who listed his/her municipality of residence as 11217 Co. Hwy R, City of MTWC. A copy of page 16 of Respondent's nomination papers is attached hereto as Exhibit D. Exhibit D contains a printout of the Wisconsin State Legislative search for representative districts, and it clearly demonstrates that the residence is located in the 2nd Assembly District, not the 25th Assembly District, in contravention of section 8.15(3).
10. Page 25, line 3 of Respondent's nomination papers is signed by an individual who listed his/her municipality of residence as 907 Schatzie La., City of Manitowoc. A copy of page 25 of Respondent's nomination papers is attached hereto as Exhibit E. Exhibit E contains a printout of the Wisconsin State Legislative search for representative districts, and it clearly demonstrates that the residence is located in the 2nd Assembly District, not the 25th Assembly District, in contravention of section 8.15(3).
11. Page 14, line 5 of Respondent's nomination papers is signed by an individual who listed his/her municipality of residence as 6015 Clover Rd., Town of Newton. A copy of page 25 of Respondent's nomination papers is attached hereto as Exhibit F. Exhibit F contains a printout of the Wisconsin State Legislative search for representative districts, and it clearly demonstrates that the residence is non-existent and therefore not the 25th Assembly District, in contravention of section 8.15(3).
12. Page 25, line 10 of Respondent's nomination papers is signed by an individual who listed his/her municipality of residence in illegible handwriting. A copy of page 25 of Respondent's nomination papers is attached hereto as Exhibit F. Without a legible

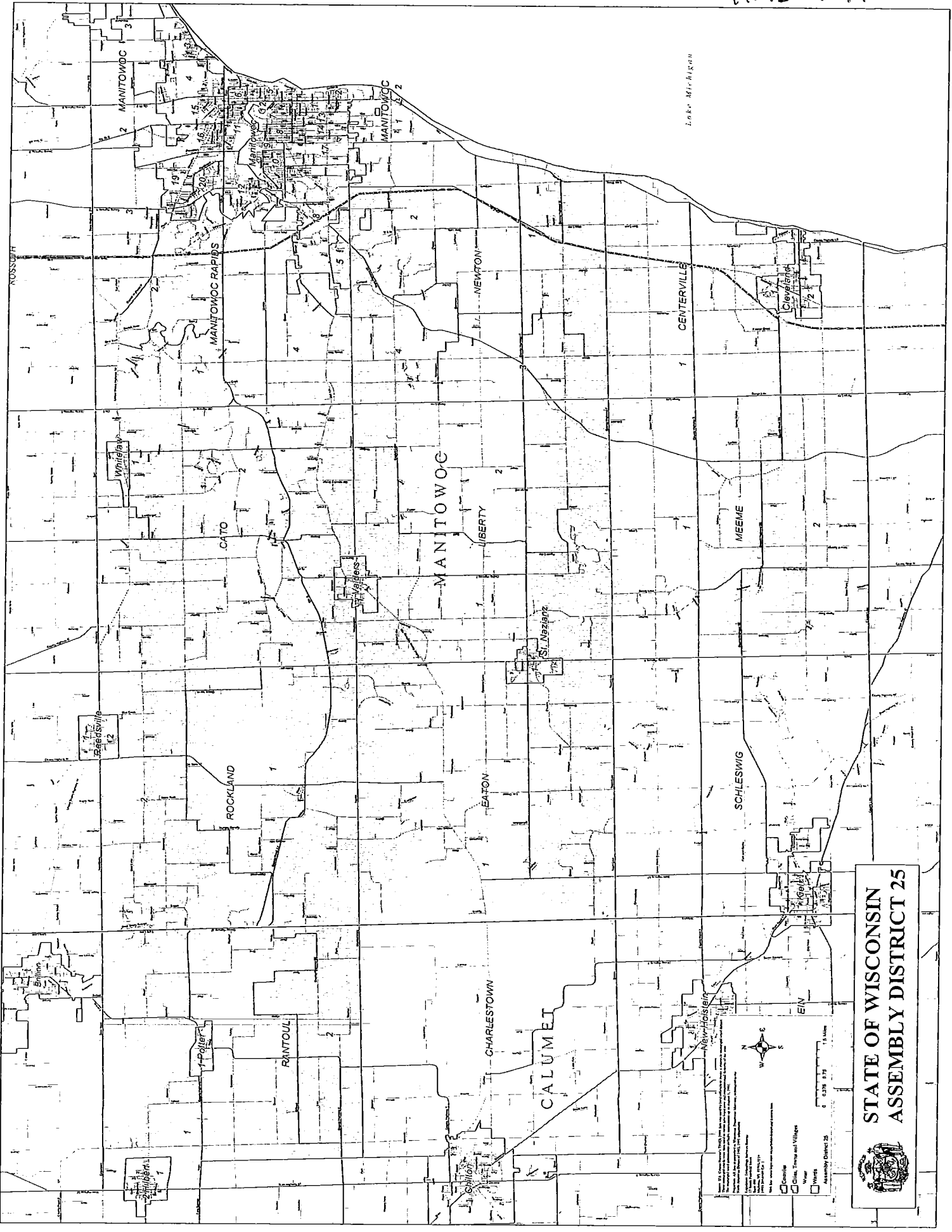
address the Government Accountability Board is unable to verify whether the address is within the 25th Assembly District.

WHEREFORE, Complainant prays that the Government Accountability Board review the sufficiency of Respondent's nomination papers and declare them to be invalid in whole or in part; and render such other relief that the Government Accountability Board may deem just and equitable.
