PRESIDENT OF THE UNITED STATES
FALL GENERAL ELECTION NOVEMBER 8, 2016**

THURSDAY, DECEMBER 1, 2016

The Washington County Board of Canvassers met on Thursday, December 1, 2016, at 9:00 a.m. in Rooms 1014 and 1020 of the Washington County Courthouse, West Bend, Wisconsin, for the purpose of conducting an election recount of the November 8, 2016 fall election for the President of the United States race.

Ms. Merten called the meeting was called to order at 9:00 a.m. and the Affidavit of Posting was read.

Ms. Jaszewski read the following:

Pursuant to the Order for Recount issued by the Wisconsin Elections Commission on November 29, 2016, Washington County will be recounting the ballots cast within the county for the Office of President of the United States.

The complete Rules for Observers are posted inside and outside the recount rooms. While the following items do not constitute a complete list of the rules, and this list may be updated at any time by the Board of Canvass, all observers are to be aware of the following:

All references to "Observers" include anyone in the recount rooms that are not Board of Canvass Members, Tabulators, County Clerk Staff, or Security hired by Washington County.

Candidates, Candidate representatives, Political Party representatives, and Media are all considered "Observers" for the purpose of the recount.

- 1. Cell phones must be silenced and no talking on a cell phone will be allowed inside the recount room or immediately outside the recount rooms if it disrupts the Board of Canvass or Tabulators.*

2. *The following items cannot be brought into the recount rooms.*
 - *Coats*
 - *Purses*
 - *Briefcases*
 - *Backpacks*
 - *Camera Cases*
 - *Pencils*
 - *Writing instruments containing any color ink other than RED.*

Observers: Absolutely NO FOOD OR BEVERAGES allowed in recount rooms.

3. *Only the Board of Canvassers, Tabulators, and County Clerk staff are authorized to touch ballots or any election materials. If any Observer touches a ballot, they will be removed from the recount rooms and will be unable to return for that day.*
4. *Only candidates or their designated Representative may make challenges or objections and these challenges or objections must be made directly to the Board of Canvass, not to Tabulators or County Clerk staff.*
5. *Only Candidate Representatives will be guaranteed an unobstructed view of ballots as they are sorted into the specific candidate stacks. Only Candidate Representatives may challenge decisions of the Board of Canvass or Tabulator as to voter intent.*
6. *Observers may not impede, interfere with, or disrupt the recount process. An observer will be given one verbal warning and upon a second infraction, will be removed from all recount rooms for the remainder of the day. The exception to this is that there will be no warning for any Observer touching a ballot and upon the first infraction of any Observer touching a ballot, that person will be removed from all recount rooms for the remainder of the day.*
7. *All observers must sign in and sign out each and every time they enter the recount rooms or leave the recount rooms.*
8. *All observers must remain behind the orange lines on the floors.*

Meeting Room 1014, will be considered the main recount room. The adjacent meeting rooms 1020 and 1026 will be used as secondary recount rooms. All observers exit and enter each room from the hallway and may not use the internal doors between the rooms.

County Board Meeting room 1019 and meeting room 1041 across the hall are available for use by observers and media. Washington County is not responsible for personal items.

Washington County does not offer public WiFi service.

The recount rooms will be locked over the lunch period and in the evenings and there will be no access for observers.

All ballots are currently secured in the County Clerk’s vault on the first floor and will remain inside this vault until the Board of Canvassers directs County Clerk staff to bring the ballots into this room. Once a reporting unit’s ballots have been counted and secured, they will be returned to the County Clerk’s first floor vault.

During the recount, the Board of Canvass will refer to the Wisconsin Elections Commission Election Recount Procedures manual dated November 2016 for guidance, but reserve the right to use procedures as described at the Wisconsin Elections Commission’s webinar held on Wednesday, November 30, 2016, or as deemed “best practice” by the Board of Canvass.

Mr. Annen objected to the rules regarding the candidate representatives and assistant representatives.

It was announced that all ballots in Washington County will be hand counted for the recount.

Poll List Reconciliation: Pages 14, 35, 125, 179 and page 7 of the supplemental list were verified. County Clerk staff, in reviewing the Town of Barton election materials for the recount, discovered the voter count was off by 23 in both the County and Municipal pollbooks. The municipal clerk and deputy clerk came into the County Clerk's office to reconcile the voter count discrepancy and found 23 absentee voters on the absentee log that were not included in the pollbooks because they came in after the pollbooks were printed. Absentee ballot #A974 certificate was missing a witness signature and was incorrectly processed and counted. Exhibit A - A duplicated ballot was removed from the count. Exhibit B - A draw down of one absentee ballot was conducted. The Wisconsin Election Commission (WEC) was contacted regarding a federal write-in absentee ballot that did not have a certificate and whether it should be counted. The Board of Canvass, by unanimous consent, agreed to pull the federal write-in absentee ballot and not count it, as recommended by the WEC.

Poll List Reconciliation: Pages 19, 48, 164, 231, and 280 were verified. The box containing the absentee ballot certificates was not sealed and only signed by two inspectors. Absentee ballot #A156 certificate was missing a witness signature and was incorrectly processed and counted. Exhibit A - A draw down of the absentee ballots will be required. Mr. Annen objected to the way the absentee ballots were handled during the drawdown. The poll book incorrectly lists 846 absentee ballots and the recount determined there were 847 absentee voters. Absentee ballot #A567 certificate envelope contained another certificate envelope. The absentee ballots and certificates counts were 847. The Board of Canvass, by unanimous consent, did not reject absentee ballot #A567. Exhibit B - A ballot was undetermined, two Board of Canvass members gave the vote to Clinton and one Board of Canvass member gave the vote to the invalid write-in.

Poll List Reconciliation: Pages 41, 99, 195, 290, and 327 were verified. The seal number for ballot box #3 was written incorrectly on the Inspectors' Statement. The Inspectors' Statement showed seal #K618801 and the actual seal number was #K318801. Mr. Annen objected to a Board of Canvass member correcting the Inspectors' Statement with the actual seal number for ballot box #3. Exhibit A - Voter #A558 absentee certificate was missing a witness signature, the Board of Canvass did identified the certificate as an in-person absentee registration and by unanimous consent agreed to count the ballot. Mr. Annen objected to the Board of Canvass's decision to count the absentee ballot. Exhibit B - A ballot was identified as a vote for Trump.

Poll List Reconciliation: Pages 10, 29, 70, 82, and 88 were verified. The Municipal Clerk indicated that the poll workers did not identify the duplicated ballots when they remade them. Exhibit A - The Board of Canvass identified two ballots that had only one election inspector's initials. Exhibit B - The original ballots that were duplicated ballots were processed by the election inspectors' initials of ng and dhk. The Board of Canvass, by unanimous consent, determined that Exhibit B was an invalid vote.

Poll List Reconciliation: Tabulators discovered that the poll book pages were very mixed up and the election inspectors put each supplemental letter in with the regular letters. The tabulators put the poll books back in numerical order and verified pages 21, 61, 114, 193 and 243. In the municipal poll book on page 193, a voter number was not written in but a voter signed the poll book. The county poll book had the voter number and voter signature. Exhibit A - Absentee Ballot Certificate #A628 was missing a witness signature, the municipal clerk was contacted by phone and indicated that this was in-person registration and verified issuing the ballot. The Board of Canvass by unanimous consent agreed to count the ballot, as the missing witness signature was due to municipal clerk error. Mr. Annen objected to the Board of Canvass's decision to count the ballot.

Exhibit B - Absentee Ballot certificate #A334 was missing a witness address. The Board of Canvass determined that this was an in-person absentee voter and identified the initials of the municipal clerk.

Exhibit C - Absentee Ballot certificate envelopes #A440, #A300 #A386, and #A81 did not have a witness signature. The Board of Canvass determined that these were in-person absentee registrations and by unanimous consent agreed to count the ballots. Mr. Annen objected to the Board of Canvass' decision to count the ballots.

Three regular ballots only had one poll worker's initials.

Exhibit D - There were 23 identified duplicated ballots with only 22 originals. The originals were in numeric order, one original was not identified to the original number. The Board of Canvass identified original number 18, which did match the duplicated ballot.
