If they do not have to show you their license, how can we verify the correct name to comply with HAVA checks	Voters have never had to produce their DL when providing their ID number unless they are using it for POR and/or photo ID.
How long can we use the old forms?	There is no established deadline.
Is this webinar considered an hour of training?	Yes!
Not having name on app match DL will create extra work, especially the middle name issue, just saying	The voter should list their name as it appears on their WI DL or state-issued ID, if they have one or the form of POR they provided.
Is the new Election Administration Manual available at this time?	No, we are in the process of updating and now need to include statutory citations which take additional staff time.
Does block 8 also apply when this form is for a change of address?	The form is used for new registrants, voters with address changes or name changes.
If a new clerk has already submitted the required training to WEC in order to get access to WisVote, do they still need to record their training in the system?	Yes.
My public service bill does not reflect my DL; WisVote will flag it!	Data review may be necessary if they don't match.

Is the clerk training report confidential?	No, it's public information.
Re voter registration form - I thought name provided should be as on DL? not proof of residency form?	Per instructions on back of form: as it appears on WI driver license or state-issued ID card or the proof of residence document used.
