At some point, please explain why we cannot use a poll book just for absentee voters. And any tips you have for the most efficient process for absentee ballot processing throughout day. Thank you!	By state law, voter numbers must be issued in a sequential order. If you use a separate poll book, you would need to use an additional set of voter numbers, which is contrary to state law.
What is expiration date for photo ID for the November election?	Certain photo IDs may not be expired after the last General Election or November 6, 2018. Keep in mind that there are different standards for different types of photo ID. Please check the manuals or the WEC website.
for provisional ballot – one reason at registration and one reason at poll book. Period. Correct?	Yes, a provisional ballot must be offered if a voter is unwilling or unable to provide their WI driver license or state issued ID card number (if they have been issued one) or their photo ID.
For a college ID, please repeat what may be offered for proof of enrollment electronically vs. hardcopy?	A University, College or Tech College student may provide their secondary documentation – proof of enrollment - electronically.
If the only thing missing is the witness address, may the clerk cure that and provide the witness address when known.	Clerks can use any means available to them to supply the missing witness address and should initial next to the addition on the certificate envelope.
Scenario 6 - can the voter leave the polling place, then sign the ballot a second time with a witness outside? acceptable?	The witness must see that the ballot was blank to begin with as part of the witness process.
IF THEY CLAIM THEY LOST THEIR BALLOT - AND DON'T WANT TO WAIT IN LINE TO VOTE. CAN WE GIVE THEM AN ABSENTEE BALLOT?	If a voter appears on election day and has not returned their absentee ballot, they can vote at the polling place. They do not vote another absentee ballot.
What if the Voter comes in and has an out of State Driver License?	Out of state driver licenses may never be used for photo ID.
What if the University ID does not have an expiration date?	Students IDs must have an expiration date no longer than two years from the issuance date to be considered acceptable photo ID. If the student ID does not have an expiration date, it cannot be used as photo ID.
If they do the IDPP process at DOT. Does this cancel their DL in other states?	We do not know.

Due to COVID, is using tape to seal the certificate acceptable?	Clerks must use their best judgement. The best practice is to reach out the voter and ask if tape was used. It is very possible that voters are using other means to seal their ballots due to COVID. If you cannot get ahold of the voter, you will have to decide if it is due to the current health situation or the ballot was tampered with.
If someone claims they never received an absentee ballot or sent it in, and there is a returned watermark what can the voter do to challenge the absentee ballot?	The voter can cast a ballot and the election inspectors may challenge their ballot if they think the voter already cast a ballot for that election.
#4 Voter brings in and wants to vote absentee and have you sign on Election day?	Election inspectors may not serve as witnesses. The voter should discard the absentee ballot and vote at the polls on Election Day.
What about in person voting? Can they vote and then change their mind the next day and want their ballot spoiled?	Yes, they can if they spoil their absentee ballot by the applicable deadline. The deadline is the end of the clerk's in person absentee voting hours and should be made in writing.
If an error is made in the poll book, should the incorrect marking be lined through and corrected or can white-out be used? (voter number, etc.)	Line through the error and note on the Inspectors' Statement.
Does the "everyone is entitled to 3 ballots" not apply to absentee voters in the instance you were just talking about where they want to vote differently than what their absentee ballot was voted	It applies to absentee ballots and Election Day ballot requested by the voter. A combined total of three ballots.
Where can we print out the information on the screen for others to use?	It is posted with the webinar access info in Recent Clerk Communications.
If they come in with a signed but not witnessed envelope, can they re-sign it and have someone witness it?	The witness is supposed to see that the ballot was blank before the voter cast their choices. If it was witnessed, the witness will have to come into the polling place to remedy the ballot.
I do not think the inspectors will be able to tell if the person on the ID resembles the person standing in front of them with a mask on. Should each voter pull their mask down so the inspectors can actually see their face?	In some circumstances it may be appropriate, in others it will not.
If a voter marries and hyphenates her name is, she required to complete a voter registration?	If she wants to re-register under that name.
Does the school ID need to be from a WI school?	Yes.
If discarding the absentee ballot on election day should the inspector discard it for them?	The inspectors may do so or the voter may do so.

Allison, did you get a chance to look into Military or Overseas absentee envelope missing DOB, can the Clerk fill it in after contacting the voter?	Thanks for the reminder Yes, clerks can add this information.
You really want a shredder at the polling place?	Point taken.

But the witness is certifying the voter was the one who voted the ballot. How does a new witness certify that?	If there was an original witness to the absentee ballot, that is the only witness who can remedy or fix the missing information on the certification.
if a voter brings in their absentee ballot, but end up getting one in the polling place for any reason, do we damage the absentee ballot somehow, or keep it?	The absentee ballot is discarded, either by the inspector or the voter.
When is the name of the absentee voter announced? When you open the envelope, at the poll book or both?	We have received this question lately and are working on a response.
so, they do not need to re-register for hyphenated name?	They will have to reregister, but this is photo ID requirements.
What if the photo ID has expired? Such as an old passport?	Some other form of photo ID will need to be presented.
Can a voter use a Passport if the address is in another state?	There typically is not an address on a passport, but yes, it can be used. The address does not have to be current.
If they are discarding ballot to vote at polls can we shred it for them?	Municipalities should come up with their own process.
Always curious how polling places with 2 or 3 splits in the poll books handle giving out voter numbers.	They typically have another inspector who hands out voter numbers to the inspectors or they have a communal stack that they are very careful to share.
If a voter comes to the polls and has an "absentee issued" water mark, but has not returned the ballot, are we able to ask them to return that ballot that is still out there?	No, they do not have to bring the ballot with them.
Just to confirm. If the absentee ballot has been returned and the voter wants to spoil it and vote a ballot in person, they cannot. Or can they if the absentee ballots have not been run. We have been asked this by voters in the last two elections.	An absentee ballot returned cannot be spoiled at the polling place, even if it has not been processed by the election inspectors.
Regarding Photo ID...What about the "Valid Without Photo licenses?	Yes, those are acceptable. They are issued to voters with a religious objection to being photographed.

<p>Should absentee ballots be destroyed rather than spoiled and put in the spoiled ballot env. and put on incident log?</p>	<p>They are not spoiled ballots on Election Day. They should be discarded by the voter or the election workers.</p>
