


Official Ballot for Partisan Office and Referendum November 4, 2014

Notice to voters: This ballot may be invalid unless initialed by 2 election inspectors. If cast as an absentee ballot, the ballot must bear the initials of the municipal clerk or deputy clerk.

Instructions to Voters

If you make a mistake on your ballot or have a question, see an election inspector. (Absentee voters: Contact your municipal clerk.)

Connect only 1 arrow in each contest.

- To vote for a name on the ballot, complete the arrow next to the name like this .

- To vote for a name that is not on the ballot, write the name on the line(s) marked "write-in," and complete the arrow next to the name like this .

Shall section 9 (2) of article IV and section 11 of article VIII of the constitution be created to require that revenues generated by use of the state transportation system be deposited into a transportation fund administered by a department of transportation for the exclusive purpose of funding Wisconsin's transportation systems and to prohibit any transfers or lapses from this fund?"

Referendum (Cont.)

School District

Shall the School District of Black River Falls, Jackson, Clark and Monroe Counties, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$22,500,000 for the public purpose of paying the cost of a school building and improvement program consisting of construction and equipping of a new elementary school on District-owned land at the Forrest Street site; construction and equipping of an addition to the High School; renovation of existing High School science rooms and labs; secure entrance renovation at Forrest Street and Gebhardt Elementary Schools, the Middle School, and the High School; construction of a parking lot at Forrest Street Elementary School; demolition of Third Street Elementary School and redevelopment of the site; and removal of portable classrooms at Forrest Street and Gebhardt Elementary Schools?
