Anderson then instructed the Tabulators on their duties and the recount process began at 9:30 a.m..

Drawdown ballots chosen reduced Prosser count by 2. Christopher Hagen voted absentee, but Kevin Hagen was indicated on the poll list as a voter. Municipal poll list missing #s 72 & 73 on page 45, and voter #90 – pg 41 (Barry Nielsen) voted absentee and is not designated with an “A” on the poll list.
